# Administrative

Chairman Tredy stated that Laurie had brought in the new zoning maps which have revisions. I have not seen them until tonight and Laurie has been dealing with them so I am going to ask her to explain them to the board.

Laurie Clune stated that the last revision was in 2003. So since then the Township has done a lot with redevelopment, the town center, environmental conservation zone so it is

clear now that the zoning map needed to be updated. She showed the changes on the map and gave a brief explanation as to the changes.

Chairman Tredy stated that we need to set our November meeting date. Our regular date would be November 20, 2008 and that is the League of Municipalities Convention at that time and many members will be attending. So I would like to see if we could change that meeting date.

Laurie stated that there is either Monday the 10th, Monday the 17<sup>th</sup>.
