NEW BUSINESS

DOCKET NO. 12.08.BA Donna Lee Ploplis 18 Spinnaker Way Block 120 Lot 5 Bulk Variance

The attorney swore in Donna Lee Ploplis and Anthony Graziano Jr. Anthony stated that they were before the board because they wanted to put up a 10 by 10 shed for storage of lawn movers etc. We have no other option of storing because there is no basement.

Chairman Tredy said that you are here for lot coverage and asked if that was correct. Mr. Graziano said yes that it was.

Chairman Tredy stated that according to our engineer your property is 30% lot coverage is permitted and you are requesting a variance for 35.4 % is that correct. Mr. Graziano said that is what he believes.

Chairman Tredy said existing now you have three detached sheds already on the property. Mr. Graziano stated that he now has two Rubbermaid sheds he removed one already. I understand that you are proposed to get rid of all three and put in one 10 by 10 shed. Mr. Graziano said that is correct.

Wayne McVicar asked if he brought in the pictures that he had requested.. Mr. Graziano said yes he did. The attorney asked him to put the addresses on the back of the pictures. They are marked ZBA 1, 2,3 and 4. Ms Ploplis described what each picture depicted. Mr. Graziano also had pictures of similar properties which were marked as Exhibits 5 thru 20.

Chairman Tredy explained that the client is going to remove the sheds and will put one in place of them. This means that they are asking to do this to make the property better.
