Attorney Rumpf swore Joy Hernandez in. Mrs. Hernandez stated that she would like to have a hairdressing business in her home.

Engineer Jeffries said that according to records in 2011 Mrs. Hernandez completed an addition to her home and he asked her to describe the size of the addition.

Mrs. Hernandez stated that the addition is 12 x 16 and it intended to be a pantry, washroom, mudroom, and laundry room. She said that the proposed hair saloon would be in a portion of that space. She intends to put one hairdresser chair, there is already a sink that would be used for the washing hair and there is also a chair at that. She only intends to have one client at a time. She has parking for one clients car and she would be the only person servicing the client. There is a separate outside door for the business. The hours of operation would be from 11:00 a.m. to 7:00 p.m. She has about one delivery a month by UPS during normal business hours. She would not be open on weekends.

She said her clients are mostly friends and family. She may see 5 clients a day and only 2 maybe 3 days a week. She doesn't feel that there is any negative impact on her neighbors. There is another business in the neighborhood also, which is a T-Shirt business. There is also a neighbor that is a painter who has his office in his home.

Engineer noted that there are two other issues on the property. One is shed that is not within the setback required of 3 feet, Mrs. Hernandez said that the shed was there when the bought their home. There is also a deck not within the setback of 10 feet required

Mrs. Hernandez said that the deck was also there but there was a space between the deck and pool that they felt would be dangerous we extended the deck to meet the pool for safety reasons.

Mrs. Hernandez submitted pictures of the deck and Attorney Rumpf marked them as Exhibit A-1 Thru A-11
