# • Rabies Clinic Report - Saturday, February 10, 2018, 9:30am-11am

Dolores Marino discussed there was some mess on the floor that was cleaned up.

Dana Covitz discussed there were less people than last year.

Nick Bonamassa discussed one resident inquired when the rabies clinic was over and was told in 10 minutes. The resident went home to get the dog and walked back after the rabies clinic was over. Dr. Wurst saw her as he was leaving and was nice enough to get out of his car and vaccinate the animal.

Dana Covitz discussed a number of pre-filled forms were not used. Next year, members will make sure the high school volunteers utilize pre-filled forms first.

Chairman Cecilia West inquired if anyone has further information to report on the rabies clinic.

Secretary Giardino discussed Dr. Wurst, Barnegat Animal Clinic, administered rabies vaccines to 114 dogs and 68 cats. Secretary Giardino licensed 48 dogs and 41 cats at Town Hall that day.
