The Environmental Commission first discussed the plans for 54 Main St. Diane Ambrosio discussed that Garden State Laboratories is looking to expand the parking for their vehicles.

The Environmental Commission reviewed the plans and looked at their plans for tree planting.

The Environmental Commission had no comments or recommendations for the plans reviewed for 54 Main St.

The Environmental Commission next discussed the plans for 123 Wells Mills Rd. Diane Ambrosio discussed that the plan is to make 123 Wells Mills Rd. a parking lot so that the owner can rent the other building he owns.

#### 3. New Business

Diane Ambrosio discussed that there is no new information regarding the Windfarms that the Township has received, or that would currently affect the Township of Ocean.

Ken Fekete provided an image rendering he saw in one of the local papers of what the Windfarms would look like if they were to be built locally out near Long Beach Island.

Richard Lipman discussed that the picture the Environmental Commission was viewing from the local paper really wasn't to scale for what the project would have been as the Windfarms would have been built 20 miles out from the shoreline and would not have been visible from the shore.

Diane Ambrosio discussed that the picture being viewed was not of Orstead and agreed that the Orstead Windfarm would have been built much further out. Diane Ambrosio agreed the Orstead project would not have been viewable from the shoreline.

Donald Lippincott discussed an article he read about a decommissioned nuclear plant in a different part of the country where they are trying to revive it to deal with the energy problem. Donald Lippincott discussed that nuclear power is environmentally friendly.

Diane Ambrosio discussed that the Township is hoping to do a tree planting for Arbor Day again this year.
