### **OLD BUSINESS:**

a. Docket 07-07-PB, Manuel Periera, Minor Subdivision, Block 20 Lot 1.05 Note that neither Mr. Periera nor his attorney is in attendance.

Attorney Yost stated this matter came up at last month's meeting and the board requested that Mr. Yost write a letter to Mr. Periera. Basically it gave a short recital of recent history on this and brought it to his attention that he has not moved the application and asked him if he wanted to keep it on the board's agenda and state his position. There is no one present and this board knows that the Pinelands Commission is involved so technically in order to be in front of the planning board he is supposed to have a certificate of filing with the Pinelands Commission and he does not have that. Pinelands Commission said there is not supposed to be any commercial activity but she has seen for herself that there is commercial activity and she is quite frustrated. They would like to see violations issued to force the landowner to comply with the laws that regulate his property.

Attorney Yost recommendation to the board is to no longer carry this on your agenda, just dismiss this application with prejudice. If he has any fees, if all is clear, return them and he will not be on our agenda anymore. If he wants to apply again he must come up with a new application and appropriate fees.
