### **RESOLUTION No 2015-9-PB**

Voted to adopt the Land Use Plan Element to the Town Master Plan.

Steven Yost – without standards it becomes a permitted use

Jim Oris – the zoning changes that Marty indicated, actually there is a funding for the actual creation of the zoning ordinances that implement changes along the waterfront development districts.

Chair announced that Jim Oris, of T& M will give us a presentation of the Floodplain Management Plan.

Jim Oris thanked the board and he was going to briefly revisit the Floodplain Management Plan that Patrick Jeffery presented last month in case there were members of the public present that may want to comment.

He explained that there are four phases of the plan:

- 1) Planning Process
- 2) Risk Assessment
- 3) Mitigation Strategy
- 4) Plan maintenance of the Overall Floodplain Management Plan

He said that the goal of the overall plan is to help guide the community with those issues associated with living and developing in the floodplain . Most people don't really associate waterfront living as living in a floodplain when living at the bay. They might talk about a river, or a stream that routinely floods out, most of the area adjacent to the bay rarely sees a flooding

event like we just had with hurricane Sandy. It is a very good opportunity for this community to adopt the floodplain management plan which would help raise that awareness. One of the things that came out of that storm is that now people realize that living in a floodplain means that the water can actually come over the bulkhead, come in my house and damage my property.

For those that don't have flood insurance, it is catastrophic, those that do have flood insurance it creates a set of circumstances that down the road they now are considered a property with a loss which now affects their resale value, which affects their flood insurance which affects their property values in the community. As one of the goals we would like those people to build to a higher level which would limit the amount of damage from future events.

Another benefit is that the Township will receive points in the CRS program, which Waretown is already a participant of. In the last few years the Mayor and committee have updated their CRS program which gives the residents that live in a flood zone a reduced premium in their flood insurance.

Engineer Oris asked if the Board had any questions.

Aaron Shapiro asked if FEMA is going to come up with a final plan.

Engineer Oris stated: The main vehicle of their risk assessments and how they put forward documents is typically enveloped in their flood risk mapping. The flood insurance rate maps. They serve two purposes, they guide building construction because they establish areas of flood Zone areas in different categories.

New maps are going to go thru public hearings, and then an appeal process and two to three years from now they may become law.

Aaron Shapiro made motion to open to the public and Jim Eckert seconded. Roll Call (Ayes, Shapiro, Eckert, Bonamassa, Tredy, Wetter, Petrosilli, Lippincott, Collamer
