Lou Fitchechella present for the applicant. They are asking for an approval of a one year extension of their approval. They have been pursuing all outside agency approvals and Mr. McFarland will talk about those. The real issue for the applicant has been a number of economic other issues that they have dealt with. They have just now secured 30 million dollars in a construction loan funding so they can move forward.

Graham Mc Farlane, Professional Engineer, Professional Planner. He stated that they have obtained all regulatory approvals in connection with the project. Ocean Township Water and Sewer, OCUA, Ocean County Soil Conservation, DEP Cafra Permit, DEP TWA permit, DEP Portable Water, Ocean County Planning Board for site plan and also from DOT for street access. All of those permits still remain in effect and beyond the expiration period of this preliminary site plan. This is the same application that the board approved as the mixed component.

Mr. Bonamassa asked the start time, Attorney said he felt within a year.

Engineer Oris asked that the applicant, provide copies of the outside agency approvals to our office as part of any action the board might take. Attorney agrees with supplying outside approvals

Engineer Oris stated that the applicants request for a time extension is provided for in our local ordinance as well as the municipal land use law.

Mr. Petrosilli asked if the project would be under old zoning requirements or would they fall under the new zoning requirement.

Mr. Oris stated that the original approvals granted upon this project protection from any zoning changes that may occur during the period following their approval. So the extension of time will carry forward those same protections.
