Dan Collamer recused himself because he is a noticed party.

Attorney Yost stated that this is not a continuation of last month it is sort of a do over – because the applicant needed council to present the application for the LLC – we don't have to repeat the entire application but we do need enough information to make an educated vote.

Peter Petrou, Esq, - applicants attorney Chris Rosati – applications engineer Christopher Karamanos – applicant.

Peter Petrou stated that Chris Rosati is going to go over the entire application as discussed at the previous meeting.

Chris Rosati – Minor Site Plan approval for an outdoor seating area, 562 Route 9, 15.7 acre site exhibits A-1 with this meetings date of 11/1/18 colored rendering minor site plan dated June 6, 2018 with no revisions. Neighboring to the south is a vacant restaurant, wooded rear, east is wooded area for about 900 feet adjoining residential units, across Route 9 is Clayton Block. We are in two zones R1A and C1 zone. All of our activity is to take place in the C1 zone. 40 x 26 area to convert to outdoor dining area with 6 – 7 tables. The floor will be a paver floor matching existing material a 6 foot high decorative masonry wall. Possibly at the top of wall lattice work. Outdoor dining with a smoking area, not proposing any night activity, no DJ or music. No signage being proposed and hours of operation would like to have 7:00 to 1 AM. Redoing parking area for outdoor seating and we are going to relocate handicapped spaces, there will be six handicapped spaces with concrete bumper stops. Add a stripped pedestrian area for walking to entrance. Planters to demark the pedestrian approach.

Chairman Sneddon asked if the board had any questions.

Shapiro – additional planting?

Rosati stated that they were going to approach that – planting will help demark that area as well.

Petrosilli – asked if something reflective would be necessary because of the wall being in a travel area.

Rosati stated that the wall is 6 ft high and with the lighting that should be enough.

Petrosilli – canopy? Rosati – no canopy

Jason Worth, Engineer – Only area that could use reflectors should be in the rear – review your lighting at resolution compliance that the lighting is enough, also because some of the isle areas are tight.

Beck – hours would be from 7 PM to 1 AM, will the restaurant also be open during those hours or will the restaurant close at 11 PM?

Mr. Karamanos was sworn in by Attorney Yost and he stated that the kitchen would be open maybe for appetizers after 10 for the outside.

Sneddon – If the restaurant is closed will the outside patrons have access to the bathrooms? Karamanos stated yes

Shapiro – I don't think it makes sense to have the restaurant closed.

Mr. Karamanos – you are right sir, I am wrong

Shapiro – You are not going to have loud music outside Bonamassa – You are not banned from having music, you just have to comply with the noise ordinance.

Jason Worth, Engineer – Two items to cover from last meeting'

- 1. Any additional lighting there will be no spillage to other properties
- 2. Additional stripping at the entrance and exit.

Rosati - We will discuss that with your engineer about the entrance and exit.

Yost – at the hearing last month there was a second exhibit - A2 11/1/2018 Jason Worth – that depicts the entirety of the site Rosati – that is correct

Chairman stated that for the record normally we would open to the Public but let it be so noted that there is no one in the audience so we will bypass that.

Chairman asked if there is a motion.

Aaron Shapiro made a motion to accept the application with modifications that we discussed. Robert Beck seconded it. Roll Call (Ayes) Shapiro, Beck, Bonamassa Kavka, Lippincott, LoParo, Petrosilli, Sneddon

Record shows there is no one in the audience for Open to the Public

Chairman stated that the next meeting will be November 14, 2018 for Buy Rite Liquors and the meeting following that will be December 6, 2018 which will be the last meeting of the year.
