New Business: Ordinance No. 2021-12; An Ordinance of the Township of Ocean, County of Ocean, State of New Jersey, Establishing Chapter 125 of the Township of Ocean Code Entitled "Cannabis Establishments, Distribution and Delivery Services Prohibited.".

Discussion: Mr. Beck comments that the commission has the option if they don't approve the ordinance, that automatically by august 15th you will be basically enrolled / opted in, so if you do not do anything you are bound for 5 years.

Mr. Worth notes, State law mandates township some type of action to allow it or prohibit it by August this year. If not, you cannot make any new rules for 5 years. By prohibiting it this time it gives the municipality a chance to see what other rules and regulations come into play with state, because they are still some unknown.

Dr. LoParo notes, that we can regulate it a lot more this way too, that the state can pass something, but we can regulate how many where and who and when it comes in. We have discussed that we do not want smoking lounges, no free samples, and we have discussed only growing in side, in an indoor facility, if we do allow we have discussed only west of the parkway, nowhere near people.

Mr. Denning – notes his thoughts, from a planning perspective of the township, that a thriving marijuana industry in Ocean Township makes a lot sense financially. 2 percent of an average smoke shop that I've spoken to, brings in 8 to 10 million dollars of sales per shop, if you have one or two of them you are talking hundreds of thousands of dollars in local municipality, can help pay for teachers, policeman, etc.

Board members continue discussion about cannabis establishments.
