NEW BUSINESS

 Ordinance No. 2022-12 An ordinance of the Township of Ocean, County of Ocean, State of New Jersey, adopting an amendment to the Phase 1 – Route 9 Redevelopment Plan

Mr. Worth discussed that this was introduced to the committee on April 19th. This is the area near ShopRite. This amendment will allow a permitted use for one medical marijuana retail establishment in the redevelopment area. The township committee referred it to the planning board to make sure it complies with the goals and objectives of the master plan of the township. b. Ordinance No. 2022-10 An ordinance Of the Township of Ocean, County of Ocean State of New Jersey Amending to amend the Official Zoning Map of the

Township and Chapter 410 of the Township Code in order to establish cannabis use overlay zones and provide associated zoning requirements.

Mr. Worth discussed that this was another ordinance introduced to the committee on April 19th, and falls under the category of recreational marijuana. This ordinance creates two overlay zones within the EC zoning district, one off Route 9 – northern area of town and one off Wells Mills Road – Route 539. Each sets specific standards in each overlay zones to allow certain classes of marijuana cultivation, manufacturing, wholesaling, and distribution. All indoor, with certain standards of distances to residential properties and roads. This is for the recreational industry, no retail use at this time.

Dr. LoParo noted that by having this ordinance, it gives us the ability to determine where we would like it to be. In addition, any applicant would have to apply through the township committee to be licensed. Also, the town receives 2 percent of the gross.

Chairman Mr. Lippincott wanted the record to reflect that there is no one in the public to comment.
