Township Administrator Kenneth Mosca reported on items discussed at last meeting:

- 1. The budget will be put on the website.
- 2. The town confirmed receipt of accreditation package from Mr. Holzapfel's office.
- 3. The town can put up bike racks at Sands Point Park.
- 4. The town is waiting for redevelopment templates from Jersey City, Atlantic City, Perth Amboy and New Brunswick and for their fees charged for redevelopment.

Motion to adjourn Caucus/Agenda and open to the public was moved by Committeeman Reilly, seconded by Deputy Mayor Kraft. Roll Call: Kraft: Yes, Reilly: Yes, Van Pelt: Yes.

Rocco Orlando, 180 Brigantine Blvd., asked if he could have an amount for the budget.

Mayor Van Pelt stated \$9,772,000. There was an increase of \$578,272 from last year.

Mr. Orlando asked when he could receive a copy of the budget.

Mayor Van Pelt stated tomorrow morning.

Ralph Avellino, 10 Central Avenue, asked why the town has to bond for Ordinance 2008-14.

Mayor Van Pelt stated when the town bonds for certain improvements, new residents coming in help defer the costs of that improvement. If the town paid cash, the new residents would get that service for free.

Mr. Avellino reported excess trash behind Wawa.

Ken Mosca will discuss with code enforcement.

Henry Laws, 38 Ocean Grove Lane, member of Safety & Security Committee, extends the residents' appreciation of installing a light at Pancoast and Route 9.

Ron Bruno, 12 Rumson Court, commented on signs around town. Mr. Bruno suggested the town financially penalize the owners of the sign.

Mayor Van Pelt stated the town's public works yard is loaded with signs the town has taken down on a daily basis. Code enforcement is working hard on keeping up on these items.

Motion to close to the Public was moved by Committeeman Reilly, seconded by Deputy Mayor Kraft. Roll Call: Kraft: Yes, Reilly: Yes, Van Pelt: Yes.

Mayor Van Pelt commented on the budget. A 3.4 or 3.5% tax increase is not enough. The Governor has put a 4% cap on the municipalities. The town's budget is \$276,000 under cap. Next year when 4% is based off tax levy, the town will have to raise an additional \$80,000 because that \$276,000 is not going to be part of that base number. The town is going to see a radical shift in employee contracts, employee health benefits and pensions. When it comes to the budget, there are few things the town has control over. The town has control over office and equipment. The other things are either state mandated or contractual

obligations. The town has restructured the health care. The town's health care is down \$20,000. The town is not done streamlining this municipality yet. There are some very difficult decisions that are going to be made in the next few months. The budget is a reflection of that. The state is really pressuring all municipalities. The municipality has a sound fiscally responsible budget that fits the needs of the community. Lumberton let approximately 15 employees go, including 6 officers. Those are my comments on the budget. The budget will be on the internet as soon as possible.

PUBLIC COMMENT

Motion to open to the public was moved by Committeeman Reilly, seconded by Deputy Mayor Kraft. Roll Call: Kraft: Yes, Reilly: Yes, Van Pelt: Yes.

Spencer Hondros, **65 Pennsylvania Avenue**, asked if the town could use the state police for Waretown.

Mayor Van Pelt stated there are towns that are using the state police. I think the town has a very good police department. I had challenged the Committee at one time to use the County as dispatch. The towns are realizing they have to find ways to use shared services. The town is going to have to find creative ways to run this municipality. The amount of money paid on the municipal side is .369 or 40 cents. The percentage of the dollar is usually 20% municipal 63% school, the rest county.

Ron Bruno, 12 Rumson Court, stated he owns a hybrid car and they are fast vehicles.

Mayor Van Pelt stated he is a big fan of hybrid cars. I don't care if they go fast or not. I would like all township police cars to be hybrids moving forward.

Ralph Avellino, 10 Central Avenue, stated if the police budget is so extraordinary, why are we hiring more policemen.

Mayor Van Pelt stated the town fought very hard, a year or two ago, on the contract. The town went into arbitration. A judge said the town is wrong and the police department deserves 20%. Changing the arbitration laws should be a top priority for the state of New Jersey. It starts at the legislature. The town is going to grow in a positive way for the next five years. It's great to have a Shop Rite, but the Shop Rite requires security, a ladder truck and maybe another ambulance. The township is using developers to shoulder those costs.

Mr. Avellino and Mayor Van Pelt discuss the planning in Stafford Township.

Spencer Hondros, **65 Pennsylvania**, asks if the new ladder truck in Lacey could be a shared service.

Mayor Van Pelt stated the town can look into it.

Stan Bystrek, 101 Baltic Avenue, asked how affordable housing is adjusted to reflect the market.

Mayor Van Pelt stated it is income driven, not market driven. \$85,000 a year for a family of four is considered low-income. It might reduce the cost of construction for a unit. Municipalities have a buy down/buy right program, where the town can buy a home and sell it at a reduced price. The town can no longer use 50% of construction for seniors. A bill eliminating RCA's is coming out soon. The Township of Ocean has two in place that the town has not paid for. The town has 65 units going to Lakewood at \$2.5

million, and the town has another number of units going to Lakewood at \$3.2 million. It used to be that projects should be 80% market rate and 20% affordable. Now the state is leaning towards 100% of 65 units should be affordable, the town gets 2 for 1 credit. Instead of 65 units, the town gets credit for 130. The town has to provide 1 housing unit for every 16 jobs created. Shop Rite is 400 jobs. Greenbriar is protected from changes in the law because they had a general developer's agreement.

RESOLUTION 2008-181 Resolution authorizing the execution the employment agreement with Kenneth Mosca, Township Administrator for the term of January 1, 2008 – December 31, 2010:

A motion of approval was moved by Committeeman Reilly, seconded by Deputy Mayor Kraft. Roll Call: Kraft: Yes, Reilly: Yes, Van Pelt: Yes.

Committeeman Reilly stated he met with two real estate agents and developers. The real estate agent and perspective owner, who is a bulkheader, wants to purchase the property on Birdsall and Old Main Road and put in a mechanic yard.

Mayor Van Pelt and Deputy Mayor Kraft stated that use is not allowed.

Committeeman Reilly stated the other matter is Linda Reher and her engineer, William Stevens. Ms. Reher wants to build a seven-unit strip mall between 800 and 1,000 square feet.

Mayor Van Pelt stated the town is in favor of some type of building, provided it meets our architecture. Water and sewer are the responsibility of the developer.

Committeeman Reilly stated he gave her a redevelopment packet and referred Ms. Reher to another project as an example. Committeeman Reilly also stated to Ms. Reher that the town would like residential above it.

Township Administrator Mosca reported on the electrical box and MSC. Mr. Mosca spoke with various electrical contractors. Some of the contractors are working at the Shop Rite site. The town has not received a proposal. MSC wanted to put bushes or wrought iron right up against it.

Mayor Van Pelt stated MSC wanted to put up a sign on their site. Mayor Van Pelt does not want a sign on their site. They have enough visibility there.

Deputy Mayor Kraft stated the inside units get no visibility. The sign is too large at twelve feet wide. It is against the ordinance. It has to be eight feet wide.

Committeeman Reilly stated the inside units cannot market themselves if nobody knows they're there.

Mayor Van Pelt stated the owner of the buildings with the awnings have asked if they could put white lettering on the awnings. Michael Kofer is the person they want to apply the letters.

The Township Committee discussed lighting and the cultured stone wall at the Town Center.

Township Administrator Mosca stated the Fire Dept. would like the town to help them out with a new jaws-of-life for \$17,000.

Mayor Van Pelt stated go interlocal. If Waretown can go in on the ladder truck, Lacey can go in on the jaws-of-life.
