Township Attorney McGuckin stated there is a vacancy on the Governing Body in the Township of Ocean. Former Mayor Van Pelt executed a letter of resignation effective February 28, 2009. Under the municipal vacancy statute, if a vacancy occurs in a seat, which had been filled by a nominated political party, the Municipal Committee for the party in question submits three names to the township's Governing Body for review and consideration. The Municipal Committee submitted three names: Joseph Lachawiec, Frank Luna and William Sneddon. Each member of the Governing Body had separately interviewed the three individuals. Township Attorney McGuckin received a call from each member of the Governing Body requesting a resolution be prepared. Mr. Kraft and Mr. Reilly chose Joseph Lachawiec. Township Attorney McGuckin read the resolution.

RESOLUTION 2009-152 Appointing Joseph Lachawiec to serve the unexpired term of former Township Committeeman Daniel M. Van Pelt in accordance with the New Jersey municipal vacancy law.

They are true community leaders. Committeeman Lachawiec stated thank you and he will pledge to the Committee and everyone in the town that he will live up to their expectations to the best of his ability.

PUBLIC COMMENT:

Michele Rosen, 29 Bradley Beach Way, congratulated Committeeman Lachawiec on his appointment. Ms. Rosen inquired about the process of interviewing for the appointment.

Mayor Kraft stated he met with all three candidates individually for an hour each at his office on Route 9. Mr. Reilly met with all three individually at town hall.

Ms. Rosen inquired why the candidates were interviewed separately.

Township Attorney McGuckin stated there were no public meetings scheduled between then and now. The expiration time to do so is now until Monday. This was the only township meeting where the resolution could be voted on.

Ms. Rosen stated the town is allowed 48 hours for an emergency meeting.

Township Attorney McGuckin stated if necessary. There was no need for an emergency meeting. If the Township Committee wanted to interview the candidates together, they would have to do so at a public meeting.

Ms. Rosen stated if they met separately to avoid making a public advertisement because they didn't have another meeting time, that is in violation of Section 11 of the statute.

Township Attorney McGuckin stated, Michele, you are absolutely wrong.

Ms. Rosen stated thank you.

Jane Kunka, 100 Cayuga Road, congratulated Committeeman Lachawiec. Best wishes, you are going to do great. Best wishes to Mayor Kraft and Deputy Mayor Reilly.

The Committee thanked Ms. Kunka for her kind words.

Joan Tredy, 131 Englewood Ave., congratulated Committeeman Lachawiec. You will do a fine job helping to guide this town to an orderly progression to the future with a limited impact on taxes. Thank you to the Township Committee. The best way to come to a conclusion is independently. Thank you for all your efforts in coming to that conclusion.

Mayor Kraft and Deputy Mayor Reilly thanked Joan Tredy for all her efforts.

Vincent Anepete, 85 Clearwater Drive, stated he was a candidate and the process was extremely fair. There were two representatives of all five districts, a male and a female were duly elected by the entire Republican party of the municipality. There could not have been a more fair process. Candidate information was not divulged to the other candidates. Mr. Lacahawiec received ten votes, all five districts, five males and five females. Congratulations. Mr. Anepete will support the Township Committee in any way he can.

Joe Randazzo, 23 Spring Lake Blvd., inquired if there has been any progress on the addition of members on the Redevelopment Committee.

Mayor Kraft stated, "no". A lot of time was spent on the appointment of a candidate. That will be next on the agenda.

Mr. Randazzo inquired if the Township Committee could commit to giving an answer one month from now.

Mayor Kraft stated the town still needs legal guidance.

Township Attorney McGuckin stated under the statute there are particular powers and authorities that are granted. There are employees, budgets, funding requirements, etc. The Township Committee needs to understand all of that before making a final determination.

Mr. Randazzo inquired if that could be discussed at the next meeting.

Township Attorney McGuckin stated yes.

Mr. Lachawiec thanked Mr. Randazzo for stepping up at a meeting to explain all the qualifications of a Township Committee. Mr. Lachawiec will try his best to fulfill those qualifications.

Ralph Avellino, 10 Central Ave., hopes the next Committeeman will fulfill their three-year tenure. It seems strange to have a party negotiate to replace a Committeeman. The people vote and expect the Committeeman to fulfill their duty.
