William Rott, 179 Wells Mills Road, inquired if joint services with Barnegat have been instituted yet.

Mayor Kraft stated yes, it is in the beginning stages.

Mr. Rott stated he appreciates Barnegat sweeping Wells Mills Road, but it is a County road and the County services Wells Mills Road. Will Barnegat start to do the side streets?

Mayor Kraft stated that is the intent. It will be a learning process for them on which roads are County and State.

Mr. Rott inquired where he would go if his property gets damaged.

Township Attorney McGuckin stated your claim would be against the Township of Ocean.

Deputy Mayor Lachawiec stated the streets were swept in Dog Town, Bay Haven and other parts of the town.

John Petrosilli, 11 Vessel Road, inquired if the town considered filling the 5,000 gallon tanker on the side of the firehouse for hydrant flushing.

Mayor Kraft stated that tanker is usually kept full and is broken at this time.

Mr. Petrosilli stated the Bay Haven sign is gone, at the corner of Main St. and Bryant Road.

Mayor Kraft stated the town is trying to relocate the sign to the North corner.

Mr. Petrosilli stated the Workshop public comment should be limited to the Workshop agenda items.

Mayor Kraft stated the Township Committee is trying to be as kind and gentle to the public as possible.

Joe Randazzo, 23 Spring Lake Blvd., inquired how new members are appointed to committees. Is it advertised in the newspaper?

Committeeman Tredy stated the residents are unaware of the openings due to lack of interest. Residents who have an interest make themselves known.

Mr. Randazzo stated in every other job you have to post it. It should be posted.

Mayor Kraft stated it is not a job. It is a volunteer position.

Mr. Randazzo inquired if Deputy Mayor Lachawiec and Committeeman Tredy are part of the Republican County Committee.

Deputy Mayor Lachawiec stated yes. Committeeman Tredy stated yes.

Mr. Randazzo thinks Township Committeemen should resign from the Republican County Committee, due to their voting on new committee people filling early resignations.

Committeeman Tredy stated the County Committee is a party organization, not a governmental organization.

Mr. Randazzo stated the party submits three names to the Township Committee. Therefore, the Township Committeeman who is on the County Committee, can pick whomever that Committeeman wants. Mr. Randazzo inquired if Deputy Mayor Lachawiec and Committeeman Tredy voted to fill the last resignation.

Committeeman Tredy stated yes. Deputy Mayor Lachawiec stated yes.

Deputy Mayor Lachawiec inquired with Township Attorney McGuckin if voting for Dennis Tredy as Committeeman was done in a lawful manner.

Township Attorney McGuckin stated absolutely.

Michele Rosen, 29 Bradley Beach Way, was told to speak for five minutes and then noticed the Township Committee allowing someone else to go on and on. It is not fair.

Mayor Kraft stated it went beyond five minutes because there was interchange from the Township Committee.

Ms. Rosen does not see any conflict with Mr. Tredy's participation in the County Committee.

Joan Tredy, 131 Englewood Avenue, Board of Health Chairperson, wanted to volunteer for the Founder's Day Committee. According to Mr. Randazzo, that would be a conflict.

Shawn Denning, 92 Morey Place Road, suggested the township broadcast the Township Meetings on Channel 22.

Harry Dering, 15 Dock Avenue, stated Sands Point Park is in Phase IIB. When will it be done?

Committeeman Tredy stated the bulkheading has to be done first.

Mayor Kraft stated there is a timeline. The town has two weeks to sign the document and send it back. CMX has until December 31, 2009 to do anything waterbound.

Mr. Dering stated the town has done a wonderful job in getting grants for Sands Point. It is going to be a beautiful park. The only problem is traffic.
