Michele Rosen, 29 Bradley Beach Way, wished everyone a happy, healthy and wealthy new year. Mrs. Rosen stated the official Township Committee calendar reads there is one meeting a month. Mrs. Rosen inquired how the Township Committee determine who would get the professional positions based upon the Request for Proposals that was sent out, and how did the Township Committee decide on the individuals to appoint to the boards, commissions and committees. Did the town have a meeting at which these matters were discussed?

Committeewoman Wetter stated Township Clerk Ambrosio prepared the professionals' proposals and the Citizens Leadership forms and distributed them to the Township Committee. Committeewoman Wetter then discussed her choices to the Clerk.

Mayor Lachawiec stated he verbally told the Township Clerk his choices.

Mrs. Rosen stated the concept of having one meeting a month is particularly troubling due to the elimination of the workshop session. The point of having a public portion is so the public can comment on the Committee's action and have input on potential actions. In the spirit of civility, please reconsider having workshop meetings so the public can have input into the things the Township Committee is deciding.

Mayor Lachawiec thanked Mrs. Rosen for her comments. The Township Committee will consider Mrs. Rosen's requests.

Mayor Lachawiec stated a member of the public requested that public comment be placed at the beginning of the meeting. Now that it is at the beginning of the meeting, Mrs. Rosen is not happy with that.

John Petrosilli, Vessel Road, inquired if Resolution 2011-82 is funding for the new buildings and renovations to the water department.

Township Adminstration Breeden stated no. It is funding needed to upgrade and renovate the water treatment plant through the New Jersey Environmental Infrastructure Trust, which will enhance the ability of the Township to deliver water to the community. These improvements are desperately needed, especially during the summer months.

Mr. Petrosilli stated on the last meeting, the agenda had two different amounts for this project.

Township Administrator Breeden stated there are two different projects. One amount was for improvements to the Water Treatment Plant and the other amount was for upgrades to Well No. 6. The Township would like to start these projects in the spring.

Mayor Lachawiec stated New Jersey Natural Gas Resolution 2011-90 has been in negotiation regarding the franchise. The Township is insisting the franchise be one year and the Township be paid \$71,467.00 as a consideration that may not be referred to a franchise fee. Under State law, the gas company collects and energy tax in lieu of a franchise fee. The State of New Jersey failed to deliver \$142,000.00 of such energy tax relief to this Township. New Jersey Natural Gas shareholders should pay at least 50% of that or \$71,000.00. The Township Clerk will file Resolution 2011-90 with the Board of Public Utilities.

Deputy Mayor Tredy stated Resolutions 2011-90 and 91 were added late. They may not be on the public's agenda. Revised agendas are available.

Township Administrator Breeden stated Resolution 2011-91 authorizes the Township to go out to bid through RV&V for a ten-foot diameter horizontal pressure filter for the Utilities Department that will be used in the upgrades to the Water Treatment Plant and Well No. 6.

Mayor Lachawiec stated many New Jersey towns have a high iron oxide content in the water. The horizontal pressure filter removes the iron oxide from the water.
