STATEMENT: Pursuant to the provisions of the New Jersey Open Public Meeting Act, adequate notice of this meeting was properly provided by sending a copy of the Notice of Meeting to two newspapers, The Asbury Park Press and the Press of Atlantic City. The Notice was posted at the office of the Township Clerk

Mayor Wetter introduced the Township Auditor, Robert Allison of Hollman, Frenia & Allison. Mr. Allison is here to explain and answer questions on Ordinance 2015-9 and Resolution 2015-242.

PUBLIC PORTION:

Motion to open Public Comment was moved by Committeeman Lachawiec, seconded by Deputy Mayor Tredy.

Mr. Allison discussed the state of New Jersey determines a certain percentage of how much the Township can raise the budget appropriation. This is not taxes. It is the amount of money the Township wants in the budget. This year the amount is 1.5%. By statute, the Township is allowed, if it passes an ordinance, to raise it to a maximum of 3.5%. Mr. Allison advises all his clients to do this. It is a safety measure. It was done last year, and last year's budget was well below what the ordinance said it could be. It was below about \$350,000. Mr. Allison expects it to be the same again. It is a good precautionary measure in case, during the budget process, there is something outstanding that comes up, which is unknown of, and forces the Township to push its appropriations number out a little further. This gives the Township a little room. It does not mean the Township is spending anything, it just gives more room in the budget if the Township thinks it needs to budget something.

Committeeman Lachawiec inquired if the CAP bank is accumulative over the years.

Mr. Allison discussed three years, then it drops off.

Committeeman Lachawiec discussed the first third year goes away and then it is replaced by the next one.

Mr. Allison discussed yes, it is the same with the tax CAP and the appropriation CAP.

Committeeman Lachawiec inquired how much the Township has in the bank.

Mr. Allison discussed the Township has never come close to the appropriations bank. It is an antiquated thing.

Ordinance 2015-9 - First Reading - Title Only

CALENDAR YEAR 2015 - ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A: 4-45.14)

Motion to approve Ordinance 2015-9 was moved by Committeeman Lachawiec, seconded by Deputy Mayor Tredy.

Mr. Allison discussed the way taxes work in general is the first two quarters are based on the prior year taxes that were raised, as anticipated that a Township budget will be passed by the time the third and fourth payments are billed. The situation here is due to an illness within the Administration, the budget process has been delayed and the Township is still in the middle of the budget process, however, third quarter taxes are due to go out. The state statute allows the Township to do an estimated tax billing based on preliminary projections. When the budget is finally struck, any adjustments will be made in the fourth quarter billing.

Committeeman Lachawiec discussed the reason the Township does not have a budget to work on right now is due to the illness of one person.

Mayor Wetter discussed due to the illness of one person and the CFO is new. Christine Thorne retired.

Mr. Allison discussed the Administrator, who is the longest tenured person here, has been ill.

Committeeman Lachawiec discussed in 2009, John Adams, the Administrator, left the Township. Committeeman Lachawiec was the liaison for finance. Township Administrator Breeden was hired in April and reviewed the budget.

Mr. Allison discussed the Township Committee is capable of constructing the budget any way it wants. The state does not require a specific person to construct the budget. Mr. Allison signs the budget, stating that it balances. The Finance Officer also needs to sign it.

Committeeman Lachawiec inquired if Mr. Allison is the Deputy Administrator.

Mr. Allison discussed no, I am the Township Auditor.

Committeeman Lachawiec discussed the Township does not have anybody capable to construct the budget now.

Mayor Wetter discussed the Township has a CFO, who has been working on it.

Mr. Allison discussed his firm has been asked to do a little more this year. The Township was expecting Mr. Breeden to come back soon and it got to the point where it just became too late. The Township has been communicating with the state. The budget will be introduced this month. The state is aware of the situation and will not impose any fines.

Committeeman Lachawiec recommended that next week the budget be introduced.

Mayor Wetter discussed if Committeeman Lachawiec could please read the agenda, it states the Township is introducing the budget July 30, 2015. Mayor Wetter discussed Committeeman Lachawiec cannot come to a meeting five minutes before it starts and learn everything on the agenda.

Committeeman Lachawiec inquired when it was decided to introduce the budget July 30, 2015.

Mr. Allison discussed the state inquired where our budget is. The Township explained the situation of the illness within the Administration and the newly appointed CFO. It was then asked if the budget could be introduced in August and the state said, no that's too late, it has to be in July.

Mayor Wetter discussed it is posted on the website calendar. It is not emailed.

Township Attorney McGuckin discussed unless it is an emergency meeting for a public health and safety issue, the Township cannot meet until at least 48 hours' notice is given to the newspaper and on the website.

Mrs. Doyle inquired when the water/sewer project on 11th Street will be completed.

Deputy Mayor Tredy discussed the actual piping work should be completed in a few weeks. The paving will take place in the fall. Deputy Mayor Tredy has been in constant contact with the Township Engineer. There have been some problems with pipe locations. The records we have are 50 years old and did not have the correct locations of the pipes. They hit the lines a few times and the water had to be turned off.

Mrs. Doyle discussed during the water-shutoffs, her icemaker broke. It might be due to the sudden jolt of water that comes out, when the water is turned back on.

Deputy Mayor Tredy suggested Mrs. Doyle call the Clerk's Office tomorrow and make an official complaint.

Eileen Doyle, 243 11th Street, inquired what this ordinance is for.

Township Attrorney McGuckin discussed when the Township gets in drought situations, the Township has to determine whether or not water restrictions should be imposed. This ordinance allows the Township to do that. In the past, a resolution was adopted. An ordinance is easier to enforce. The Township Engineer will determine if there is a water emergency. Citizens will be urged to water lawns, wash vehicles or practice outdoor recreational uses on odd or even numbered days during certain hours.

Mrs. Doyle discussed her heating/air conditioning system runs on two wells and inquired if she can still use the well during a drought.

Deputy Mayor Tredy stated yes, for that purpose only. You could be asked to stop using the well to water the lawn on the wrong day.
