STATEMENT: Pursuant to the provisions of the New Jersey Open Public Meeting Act, adequate notice of this meeting was properly provided by sending a copy of the Notice of Meeting to two newspapers, The Asbury Park Press and the Press of Atlantic City. The Notice was posted at the office of the Township Clerk

Mayor Wetter introduced Freeholder Jack Kelly, who will make a special presentation.

Freeholder Jack Kelly thanked the Governing Body for allowing him to read a Proclamation from the Office of the Freeholder Director, honoring Deputy Mayor Dennis Tredy for his dedication and commitment, serving the residents of the Township of Ocean in many capacities as a member of the Land Use Board, Zoning Board, Planning Board, Committeeman, Mayor, Waretown Volunteer Fire Company and his current position of Deputy Mayor. On June 25, 2015, Dennis Tredy graduated from the Ocean County Fire Academy, along with five other cadets from Station 36 Waretown Volunteer Fire Company, as the oldest candidate ever to graduate from the Ocean County Fire Academy.

Deputy Mayor Dennis Tredy thanked Freeholder Kelly, his wife Joan Tredy, and his family, who are in the audience and who stuck by him attending the many classes at the Fire Academy.

Deputy Mayor Tredy also thanked the Township of Ocean Police Officers, Firemen and employees who took the time to be here tonight.

Committee Reports

Mayor - Tina Wetter

As previously discussed, the Township, with the assistance of Greenbriar residents, were successful with securing a new traffic signal for the Route 9 and Pancoast Road intersection. Currently, the New Jersey Department of Transportation has contacted the town to apply to JCP&L for the electric service and obtain a DR #. JCP&L has given the Township the DR# and it has been forwarded to the Department of Transportation. The New Jersey Department of Transportation handles all aspects of this work for the new signal. This work is anticipated to take a few months to accomplish, but the project is steadily moving forward and we are hopeful for a new traffic signal at this intersection during the fall of 2015.

Committee Reports

Deputy Mayor - Dennis Tredy

1. Recreation

Improvement and upgrade work has completed to the tennis and basketball courts at the Waretown Lake along with enhancing the various hard court surfaces at Tuomey Park. There is a change order on tonight's agenda for a decrease in the original contract amount by 2.7%, which is about \$8,000.

2. Bryant Road Gazebo

The reconstruction of the T-Dock is complete as well as the majority of the bulkhead and walkways. The final utility lines were removed by Comcast and the utility poles were removed. It is expected that the entire project will be completed within 2–3 weeks.

3. <u>Lightning Protection Improvements on the various Township Towers, Water Treatment Plants</u> The work on this project is complete and final inspections were performed.

4. DOT – Projects – Oregon & Pocahontas

The NJ Department of Transportation has authorized a grant for 2014 in the amount of \$190,000.00 for paving the road. The Township's policy when a road is to be paved, is to look at the whole project and include the drainage work as necessary. Tonight there is a bond on the agenda to cover the overage of the project. The amount estimated for the total project is \$360,000.00, a difference of \$170,000.00

The Department of Transportation has authorized a grant for 2015 in the amount of \$325,000.00. Again the Township has also incorporated drainage work that cannot be paid by the Department of Transportation under the bond that is being introduced tonight. The amount estimated for the total project is \$475,000.00, a difference of \$150,000.00.

In order to qualify for the 2016 Department of Transportation Municipal Aid Program, these two projects need to be bid. The Township also will bid them together, hoping for a better price by combining the projects.

5. Community Development Block Grant

This grant is ADA compliant improvements. The Township has been approved for a \$32,000 grant to make improvements to Town Hall's sidewalk and doors. The estimated costs for the entire project are \$65,000, a difference of \$33,000.00. This is also included in tonight's bond ordinance. As the Municipal Complex is older, it is important to have it be in compliance with the ADA standards.

Committee Reports

Committeeman - Joseph Lachawiec

On the agenda tonight is the second reading for the Comcast Cable franchise ordinance. Rob Clifton, a representative of Comcast, was here at the last meeting and explained what the Township needed to do for a franchise. Mr. Clifton discussed the fee is negotiable. The franchise amount is \$22,000 for 20 years. Every Township gets the same amount. That is not a negotiation. Committeeman Lachawiec discussed asking for additional funds, as cable also brings in the internet and telephone.

Deputy Mayor Tredy discussed the Township is receiving \$50,000.

Mayor Wetter discussed Mr. McGuckin is going to explain the franchise during the public comment of the second reading of the ordinance.

PUBLIC PORTION:

John Petrosilli, 11 Vessel Road, discussed the Township is bonding over \$4 million. Last year the Township bonded quite a bit to cover all these projects. Mr. Petrosilli inquired how much the Township bonded in the last year and a half.

Township Clerk Ambrosio will give Mr. Petrosilli the amount tomorrow. It is in the budget, which was not brought to the meeting tonight. The budget is on the website, if Mr. Petrosilli would like to review it.

Mr. Petrosilli inquired if the Bryant Road gazebo and dock project will have signage prohibiting bicycles and skateboards. Mr. Petrosilli discussed placing garbage receptacles at the dock.

Deputy Mayor Tredy discussed yes, there will be signage prohibiting bicycles and skateboards and whatever is necessary to keep the area clean and neat.

<u>Ordinance 2015-6 – Second Reading – Public Hearing – Comcast Cable Franchise</u>
AN ORDINANCE GRANTING RENEWAL OF MUNICIPAL CONSENT TO COMCAST OF NEW
JERSEY. TO CONSTRUCT, CONNECT, OPERATE AND MAINTAIN A CABLE TELEVISION
AND COMMUNICATIONS SYSTEM IN OCEAN TOWNSHIP, NEW JERSEY

Township Attorney McGuckin discussed the Township had negotiations and discussions with Comcast on a number of occasions. Based on those discussions, Comcast agreed to raise their proposal to \$50,000. It is a separate side agreement between the municipality and Comcast, as the Board of Public Utilities (BPU) might not approve the agreement if it was in the actual agreement. The Township cannot change

federal law. Toms River has 20 times the number of customers that the Township of Ocean has and received approximately \$100,000.

Committeeman Lachawiec discussed the ordinance states a 15 year term.

Township Attorney McGuckin discussed a 15 year term, with a 10 year renewal, for a total of 25 years. It was \$22,000 for a 10 year initial approval. Then it was \$25,000 or \$30,000 for a 10 year with a 5 year renewal.

Committeeman Lachwiec discussed that is not such a good deal.

Ordinance 2015-10- Second Reading - Public Hearing

An Ordinance of the Township of Ocean, County of Ocean, State of New Jersey adopting certain regulations of Drone Technology and unmanned aircraft for the Township of Ocean

Township Attorney McGuckin discussed the ordinance defines unmanned aircraft, which is basically a model plane aircraft. The ordinance does not specifically indicate that it is not covered by this ordinance. A question could arise to someone who is flying a model airplane, which does not have a camera, recording device, or other sensing data, that would be covered under the ordinance.

Township Attorney McGuckin suggested the Township amend the Ordinance, Section E.1., to indicate the ordinance does not apply for an unmanned aircraft by any federal, state and local agency including but not limited to law enforcement and emergency services agencies or by any person or persons for lawful purposes and in a lawful manner.

Township Attorney McGuckin also recommended deleting #2 under that paragraph. It is a little bit confusing. It is a fair amendment to indicate the Township is not trying regulate unmanned aircrafts, model aircrafts. People still have to fly them in a lawful manner.

Motion to amend Ordinance 2015-10, Section E.1., to indicate the ordinance does not apply to unmanned aircraft by any federal, state and local agency including but not limited to law enforcement and emergency services agencies or by any person or persons for lawful purposes and in a lawful manner and deleting #2 under that paragraph was moved by Committeeman Lachawiec, seconded by Deputy Mayor Tredy.

Ordinance 2015-11- First Reading - Title Only

AN ORDINANCE OF THE TOWNSHIP OF OCEAN, IN THE COUNTY OF OCEAN, NEW JERSEY, PROVIDING FOR VARIOUS CAPITAL IMPROVEMENTS AND OTHER RELATED EXPENSES IN AND FOR THE TOWNSHIP OF OCEAN AND APPROPRIATING \$1,088,000 THEREFORE, AND PROVIDING FOR THE ISSUANCE OF \$513,950 IN BONDS OR NOTES OF THE TOWNSHIP OF OCEAN TO FINANCE THE SAME.

Jason Worth, T&M Associates, discussed this bond ordinance covers several projects. The grants received from the NJ Department of Transportation are reimbursement grants. The municipality has to bond for that money first and then will be reimbursed.

Covered in this bond is improvements to Pocohontas Avenue for \$360,000 and Oregon Avenue for \$475,000, as well as the Community Development Block Grant (CDBG) project and improvements to the Pebble Beach Water Treatment Plant. Through the process, it has come up that there are other issues at the site, which need to be rectified to bring into compliance with DEP regulations, so there is money in the bond to take care of those issues as well. Of the bond, there is \$547,000 in grants that the Township will be reimbursed to offset the costs.

Committeeman Lachawiec discussed the Township is appropriating \$1.08 million, bonding \$513,950, and will be reimbursed \$547,000.

Township Engineer Jim Oris, T&M Engineering, discussed that is correct. The money that is reimbursed needs to be appropriated in order to spend it. The bonding reflects what the Township will ultimately have left over in debt.

Committeeman Lachawiec inquired if the reimbursement will be targeted for retirement of the bond or will it go into general funds.

Township Engineer Oris discussed the reimbursement goes directly back and cannot be spent for something else.

Jason Worth discussed this bond covers the 2016 NJ Environmental Infrastructure Trust (NJEIT) project. The project covers water/sewer main drainage and roadway improvements within the Pebble Beach area of the Township, Maplewood Road, Teaneck Road, Harborage Place, Stillwater Road, Dune Lane and Englewood Avenue. This project is an extension of the ongoing projects in that area. It is the oldest section of water/sewer infrastructure in the municipality. When the project is bid and awarded, the amount to be funded corresponds to the amount bid. The Township obtained \$2.1 million of principle forgiveness last year, so a significant portion of that project will not be paid back.
