Committee Reports

Mayor - Tina Wetter

1. Finance - 2015 Budget

Tonight the Township will be adopting the 2015 municipal budget. The Township along with the Township Auditors has been working with the State of New Jersey Department of Community Affairs to have the budget complete. Diane Ambrosio, Municipal Clerk, worried, lost sleep, and stayed late, to complete the budget. Thank you, Diane Ambrosio. This year even though we sharpened our pencils, the Township will have an increase of 1.3 cents. The average residential assessment of a home in Waretown is \$265,000. This increase amounts to \$34.45 per year.

By all accounts, the winter of 2014-2015 was a hectic storm ridden year. The Township had to respond to over a dozen snow and ice events during the winter that required salting and plowing of municipal roads. With snow and ice, there is no alternative or option but to respond to make sure the roads are safe for travel. Our snow crews do an outstanding job managing winter weather, but yet at the same time, we all must acknowledge there is a price for having a responsible and comprehensive snow operation.

The budget being adopted this evening represents a remarkable job of balancing the needs of sustaining a professional municipal operation versus the financial realities of our taxpayers. It is a delicate balance between the two but I firmly believe we have struck that balance with the budget being approved tonight.

Also on the agenda tonight is Resolution 2015-288 and Resolution 2015-289 for shared services with Barnegat in the Tax Office and Recreation. These Shared Service Agreements have expired and need to be renewed. The Shared Services regarding these two offices work and are a cost savings to the Township of Ocean and Barnegat and are listed in the budget documents.

Resolution 2015-307 and 2015-308 discuss new signature cards for Ocean First Bank. The cards need to be updated due to the retirement of the CFO and adding the new CFO, Cliff Keen, to the accounts.

2. Police - Dispatch

Resolution 2015-303 and 2015-304 discuss a dispatcher has resigned, and a part-time dispatcher who has been working here will be moved to the vacated full-time position.

The Township will now have a "Safe Exchange" Zone in the Police Department Parking lot. This will assist in making internet-based trading safer. This gives people a place to complete transactions with less risk than meeting in public or at the home of an unfamiliar person. A sign will be placed at a parking spot "Internet Exchange Purchase Location" in front of the police department for all to use. The Police Department believes this will help deter scams and possible violence or harm to an individual, as has happened in other areas of the Country.

The Ocean Township Police Department along with the Ocean County Sheriff's Department will have a Child Passenger Safety Checkpoint along with a Prescription Drug Drop Off on Saturday, September 26th at the CVS Parking lot from 10:00 am – 2:00 pm.

Deputy Mayor - Dennis F. Tredy

1. Bryant Road Park

The reconstruction of the T-Dock is complete as well as the bulkheads and walkways. The contractor is working on the benches at the end of the dock. They are coming up with a design and using materials that will match the dock.

2. NJEIT Project Bayshore/11th Street/Seneca

The company handling this project is moving along due to the good weather. The project is taking a little longer in areas due to the depths of the pipes in the ground, which are 10–12 feet deep and the area has to be dewatered to lay the new pipes. It has been an inconvenience to the residents in the area but once it is complete there will be new pipes and drainage infrastructure that the area needs. The contractor is hoping to finish up 11th Street within the next week or two depending on weather and pave the trenches and let them settle. The project will then move to Seneca Boulevard. Once Seneca is complete it has been discussed to pave the entire area of Bayshore/11th Street/Seneca, weather permitting. If these roads cannot be paved for any reason, the paving will be delayed until the spring.

3. Ordinance 2015-11 - Bond Ordinance

There are several items listed in the Bond Ordinance regarding the additional funding for the 2014 and 2015 Department of Transportation (DOT) Projects. Additional funding for various upgrades to the Town Hall to comply with Americans with Disabilities Act (ADA) regulations will be through the Community Development Block Grant (CDBG) funding program. Enhancements will be made to the Police Department to assist in it running in a safe and efficient manner including the Patrol room, jail cell area and interrogation room.

4. Ordinance 2015-12 – Bond Ordinance

This Bond Ordinance is for the New Jersey Environmental Infrastructure Trust (NJEIT) water/sewer improvements. The Township will also be addressing the drainage issues on Maplewood Road, Teaneck Road, Englewood Avenue, Dune Lane, Stillwater Road and Harborage Place for 2016.

5. Ordinance 2015-13 – Amending Property Maintenance Liens

As you can see listed on the agenda this evening are eight resolutions for property maintenance violations. The property owner failed to abate the violations within the time limits. The Township sends out the Department of Public Works to bring the property inconformity to the Township codes. This Ordinance adds an administrative fee for the violations of \$250.00 each time the Township has to maintain the property. The Township has an ordinance that allows the Township to place a lien on a property if the property is not maintained. The Township maintains the property and charges the resident according to the County's schedule.

6. Resolution 2015-290 - Pebble Beach Water Treatment Plant/Route 532 Water Treatment Plant

As this water treatment plant is aging there are items that need to be updated. Once the Township reviewed the needs of this plant, it was also discovered some items are no longer up to the Department of Environmental Protection (DEP) standards and need to be replaced. The Township will be authorizing the Township Engineer to go out for bid on these two projects.

7. Resolution 2015-291 DOT – Projects – Oregon & Pocahontas

The NJ Department of Transportation has authorized a grant for the 2014 and 2015 grants. The Township is now authorized to go out for bid. The Township is hoping by combining the two projects to have a competitive bid process. The Township has received \$515,000.00 in grant funding for these two projects.

Eileen Doyle, 243 11th Street, inquired about property maintenance and who determines what is a garden and what is weeds.

Deputy Mayor Tredy discussed there are certain types of vegetation that are considered obnoxious growth.

Mrs. Doyle discussed there is a property on Seneca Blvd., close to Route 9, that is odd. If the owner of the property is happy with it, good for her.

Deputy Mayor Tredy discussed that property owner is not a very cooperative resident. The Township checks the property often to make sure there is visibility to traffic in both directions. When there is no visibility, the Department of Public Works will cut the vegetation back, sometimes with a Police escort.

Mrs. Doyle discussed Mary Dunkley asked her to discuss with the Township Committee the EMS workers at the Community Center.

Township Clerk Ambrosio discussed speaking to the owner of Quality Medical Transport about the workers laying on the couches at the Community Center, when classes and meetings are taking place. The owner will address the issue.

Mrs. Doyle inquired about the CDBG elevator for Town Hall.

Township Clerk Ambrosio discussed that is part of the bond ordinance being voted on tonight.

Jason Worth, T&M Associates, discussed once the bond ordinance is done, the Township can go out to bid on a new chair lift, sidewalks and door openers. An elevator would be much more costly. The Community Development Block Grants are approximately \$30,000 and the Township is only eligible every two years. It is a very competitive program. The Department of Housing and Urban Development has greatly reduced how much money the towns can receive.

Mrs. Doyle discussed people who use a scooter or wheelchair do not have access to the meeting room. A hydraulic lift was discussed.

Jason Worth discussed the entrance way itself has other barriers that would require improvements and there are additional barriers at the top of the stairs.
