STATEMENT: Pursuant to the provisions of the New Jersey Open Public Meeting Act, adequate notice of this meeting was properly provided by sending a copy of the Notice of Meeting to two newspapers, The Asbury Park Press and the Press of Atlantic City. The Notice was posted at the office of the Township Clerk

Mayor Wetter discussed tonight the Township is hiring a Police Chief, Michal Rolaglski. In September of this year the Township Committee passed an ordinance creating a fair and open process for the position of Police Chief. The Township Committee enlisted the assistance of the New Jersey Chiefs Association to create a procedure and criteria to be utilized in appointing a Chief of Police.

The assistance from the New Jersey Chiefs Association was a great asset to the process. The process was created and approved by a Township ordinance. There was a two-step process that included an interview/test by the New Jersey Chiefs association and an interview/test by the Township Committee. This procedure was taken very seriously by all who were involved. After the information was gathered, the Township Committee came to a unanimous decision. Tonight the Township will approve Michal Rogalski to lead the Township of Ocean Police Department.

Michal Rogalski started his career as a special officer in February 2005. He worked his way up to full-time patrol officer that same year. In 2010 he was transferred from the Patrol Division to the Detective Bureau. In 2012 he was promoted to Sargent and began supervising the patrol squads. In 2015 he was reassigned to the Detective Bureau as a Detective Sargent. Since that time, he has achieved many honors. In 2012 he received the award for Officer of the Year. In 2016 he received the first Chief William T. Sneddon Supervisor of the Year award. This award is voted on by all Department members. During his interview, he listed this item as one of his greatest achievements to be honored by the people you work with side by side. Sargent Rogalski currently teaches Homeland Security courses at Ocean County College and instructs Police Recruits in the Ocean County Police Academy, Ocean County Prosecutors Office Instructor Law Enforcement Advance Detective School as well as instructs Law Enforcement Professionals at the West Point Command and Leadership Academy.

Michal Rogalski has always made time for the Township residents and children. He volunteers his time as part of the Big Brother/Big Sister and the Lunch Meet Program to have lunch with a student in the school district. He is a cofounder of the Junior Police Academy along with other members of the Police Department. The program was created for children of the Township to experience and learn what it

entails to be a Police Officer for one full week during the summer. He also created the safe exchange zone and the Grinch escorting Santa at this time of year. Mike has been an asset and will continue to be an asset to the Township of Ocean as Chief of Police. He is highly motivated and dedicated to this Department and the Township, committed to preventing crime and working with the Township Committee and all the residents. These are just a few of his accolades. Now let's get down to business.

Chief Rogalski discussed he is honored to stand before you as Chief of Police of the Township of Ocean. I am so very fortunate to have the opportunity this evening to share this very special occasion with my family, friends and fellow members of law enforcement. Chief Rogalski thanked the Township Committee and Administrator for this opportunity to lead this great department. You have expressed your confidence in me and spelled out exactly what your expectations are. I will, to the fullest of my ability, exceed those expectations for you, the community and for the men and women of this Police Department.

Chief Rogalski thanked his wife, Jennifer and his two sons Michael and Mason. Michael has supported me without question. He has always been there to help me no matter how crazy my ideas have been. Just last week in 24 degree weather, Michael dressed up as the Grinch. Thank you for becoming the thoughtful and respectful young man and a great son.

Thank you, Mason, for keeping me grounded. I came home pretty excited for being considered for a promotion, Mason asked, are you going to be the Chief. I said yes, Mason. Mason asked, is that like being the boss. Kind of. Mason said well Mom is still the Chief in the house.

No matter what, you always reinforced your commitment to me and for that I thank you so very much.

I immensely appreciate the opportunity that is being afforded to me by the Township Committee to serve as Chief of the Ocean Township Police Department. I am fully committed to giving everything I have for this department, the men and women that I will work with and the residents of the Township. I fully recognize that the position of Police Chief incorporates so much more than simply acting as an agency head. With this position comes a great deal of responsibility to the agency and to the community. The most important asset and component are the people you have working with you.

I have worked with many of the officers here tonight throughout my career in different capacities. Not only are these officers trained, skilled and very capable in their responsibilities, but they understand the most basic principles of law enforcement. These principles have been around since the beginning of policing since 1829 with the inventor of modern policing Sir Robert Peel. Most of the principles can be summed up in one principle, Police at all times should maintain a relationship with the public that gives reality to the historic tradition that the Police are the public and the public are the Police. The Police being only members of the public, who are to give full time attention to duties which are incumbent on every citizen in the interests of community welfare and existence. These nine principles and the one I just quoted eventually transformed into the simplified role of what is expected of law enforcement, to simply protect and serve.

It is the Police relationship with the community, the businesses, the schools, the religious institutions and the entire fabric of the Township of Ocean will remain our top concern. To the men and women of the Ocean Township Police Department, it is an honor and a privilege to stand and serve with you and to comprise the thin blue line to protect and serve this community. My commitment to you is this, as we continue to serve this community, do what is right. If you do what is right, I will be there to support you at all costs. Give it your best, and together we will make this Police Department and this community better. I will always be there to support you whenever you give it your best. I will be there to encourage you whenever you give it your best, even if your best was not good enough for that day.

More than anything else, I will always care for you and your family. When I make decisions, I will always think of your family, just as I think of my own. As the Ocean Township Police Department progresses forward, we will remain committed to three things, we will protect, we will continue to be vigilant and proactive in arresting those who break the law, especially those who victimize others and we will serve and show compassion and empathy to individuals who are in need and have called us for help or assistance. We will either provide the assistance or get them the help they need. We will improve. We will continue to strive for new ways to improve on how we can serve the needs of this great community.

While the Police Chief sets the mission statement for the agency, it is the men and women that work for the agency that set the standard. Today, we raised that standard. I challenge and expect you to set that standard for me at the highest level. I expect you to set that standard high for those around you. Always remember, as an Ocean Township Police Officer, we will always live with honor and serve with pride. Thank you so much for being here.
