Committee Reports

Mayor - Tina Wetter

Resolution 2017-104 & 105 - These two resolutions appoint a Conflict Public Defender and an Alternate Public Defender for the Municipal Court. There are times when more than one Public Defender is necessary in a case. These appointments have been requested by the Municipal Judge.

Resolutions 2017-108 & 109 - These two resolutions are for the Township to have a temporary budget. The Township is working diligently on closing the 2016 budget and being able to prepare the 2017 budget. A temporary budget must be approved to keep the Township moving forward and all expenditures are accounted for in the 2017 budget.

<u>Resolutions 2017-110</u> - Resolution appointing one part-time dispatcher, pending her final background check. In the past month there have been three (3) resignations in this department, due to each moving on to another endeavor. The Township will be hiring two (2) additional part-time dispatchers in the near future.

<u>Resolution 2017-111</u> - This resolution is appointing two (2) Class II Special Police Officers, pending their medical testing as required. These two (2) officers are replacing two (2) Class II officers that have resigned from the Police Department.

<u>Resolution 2017-114</u> - Resolution authorizing the execution of the contract between the Township of Ocean and Diane Ambrosio to be the Township Administrator for the year 2017.

<u>Resolution 2017-103, 112, and 113</u> These three (3) resolutions are appointments to various boards, the Environmental Commission, Green Team and Flood Plain Management. These appointments are to fill vacancies of members who resigned or who have left for other various reasons.

<u>Resolution 2017-107</u> This resolution authorizes the Township of Ocean to enter into a Schedule "C" Agreement with Ocean County. This agreement is necessary to purchase items the Township might need from the County or for paving that might be done within the Township of Ocean. This agreement is a financial benefit to the Township.

<u>Resolution 2017-106</u> This resolution appoints two people to the Department of Public Works. They are replacing two employees that have resigned. The employees being hired are both from Waretown and have come with great recommendations.

<u>Update on Pebble Beach – Water & Sewer Main – NJEIT Project</u>

All utility work is completed on Maplewood Road and Teaneck Road. The contractor has begun the sanitary sewer replacement on Dune Lane. Improvements include a new water main, sanitary sewer main, storm drainage and roadway repaving. The project area includes Englewood Avenue, Dune Lane, Harborage Place, Stillwater Road, Maplewood Road and Teaneck Road.
