Committee Reports

Mayor - Tina Wetter

Ordinance 2017-1 is listed for the second reading Public Hearing. This ordinance amends the personnel policy regarding supervisory responsibilities with respect to immediate family members. Personnel policies are changed on an as needed basis.

Resolution 2017-123 authorizes the submittal of two grants to Sustainable New Jersey. The first grant would be to refurbish Faust Park in the Bay Haven Section of the Township and the second one is to update the Open Space and Recreation Plan. These two projects could be funded 100% by these grants.

Resolution 2017-136 authorizes the Emergency Management Agency Assistance Grant. This money will be used to offset the salaries of the Office of Emergency Management. The total amount awarded is \$9,400.00, which is the Federal Award. The Township of Ocean has to match that \$9,400.00 for a total award of \$18,800.00

Resolution 2017-141 appoints the Emergency Management Council. This is required by the Office of Emergency Management each year.

Resolutions 2017–124, 125, 126, 127, 129, 130, 134, 137 are for overpayment of taxes and utilities. If a refund is due it must be completed by resolution.

Deputy Mayor - Dan Collamer

Ordinance 2017-2 is being introduced to amend the Redevelopment Plan for Ocean Commons. Over the next few months there will be ordinances and the Fair Share Housing Plan that will be updated. The Township of Ocean is working towards settlement of the Affordable Housing court case. The Township has been working diligently with the courts, attorneys and planners. This property will be listed in the Fair Share Housing Plan. The second reading and public hearing on this ordinance will be March 9, 2017. This is the final requirement of the Township to reach the settlement with Fair Share Housing, which has been going on a long time.

Resolutions 2017-117 through 2017-121 authorizes Shared Service Agreements with Barnegat Township. The Township of Ocean shares a Recreation Director, Construction Official, UCC Construction Code Inspectors, Tax/Utility Collector and Plumbing Subcode Official. These positions have worked very well for sharing and have been a cost savings to both Townships. These resolutions are being voted on tonight to make the change that each Township is billed for hours worked. In the past billing has been based on days in each town. This will benefit the Township in the Construction Office, which at this time is not as busy since the completion of the Greenbriar development.

Resolution 2017-138 authorizes the Township to purchase the Founder's Day Fireworks, which is scheduled for May 27, 2017 at dusk, with a rain date of May 28, 2017. The fireworks will be handled by Pyrotechnico and will be ignited off a barge at the end of Bryant Road.

Recreation

Do not forget about the 2017 Snowman Building Contest. It runs from January 1—March 1, 2017. Each entrant must build a snowman and send photos via e-mail to the recreation office or drop off photos at Town Hall. Entrants are encouraged to add their own creative touches that will make their snowman unique. A prize basket will be awarded.

Committeeman - Ben LoParo

Resolution 2017-122 updates the House Accounts. This will amend the resolution authorized at the January 2, 2017 meeting. A few companies have been removed from the list and names are updated to present billing company names.

Resolution 2017-133 authorizes the submittal for the NJ Department of Transportation grant. The Township has been fortunate over the years to obtain funding for road improvements throughout the Township. The road to be submitted for is Illinois Avenue. This road needs repairs and drainage work. The Township will be notified if the money will be awarded for the project.

Resolution 2017-139 awards the contract for the rehabilitation of the Poplar Street Pump Station. This is a large pump station in need of repairs and upgrades. The bids were taken on January 27, 2017 and reviewed by the Township Engineer and Township Attorney.

Resolution 2017-140 authorizes a change order on the Pebble Beach Water and Sewer Replacement. The project needed extra work necessary for the replacement of the storm drainage outfall on Stillwater Road, as well as re-alignment of several sanitary sewer laterals on Teaneck Road, due to their current location. The increase is 0.71%.

Update on Pebble Beach Water & Sewer Main NJEIT Project

The contractor has begun the sanitary sewer replacement on Dune Lane. Once complete the contractor will be moving to Englewood Avenue. Improvements include a new water main, sanitary sewer main, storm drainage and roadway repaving. The project area includes Englewood Ave., Dune Lane, Harborage Place, Stillwater, Maplewood and Teaneck Road.

The Township has surveyed Grand Bay Harbor Drive. The end of Grand Bay Harbor drive will be repaired to prevent erosion.

Picnic tables have been ordered for the end of Tuscarora Avenue, to make it more park-like.

The Ocean Township School District has won a major Public Employment Relations Commission (PERC) decision against the teachers' union. The School District won the right to hire who they want for stipend jobs in the district. It has been two and a half years since the School District applied to PERC and won. It is a big victory for the school board.
