Committee Discussion Items

- 96 Bryant Road

Township Administrator/Clerk Ambrosio discussed the Township now owns 96 Bryant Road. The Department of Public Works scheduled with the Department of Corrections today to assist with cleaning up the property. Green Acres and the Department of Environmental Protection (DEP) prerequisite is to not touch anything until the DEP meets with the Township on site. I have reached out to the DEP to schedule a meeting. Jason Worth, T&M Associates, has reached out to Green Acres to let them know the Township is now the owner of the property.

There is a concern about people cutting through the property. There should be chains to block people from cutting through. A berm is not safe. Township Administrator/Clerk Ambrosio discussed if the Township wants to block the Dollmore side, the berms are not acceptable for insurance reasons. Township Administrator/Clerk Ambrosio discussed the building had water up to the windows. The doors have been screwed shut. A meeting will be set up with the Construction Official on site next week.

Mayor Collamer discussed something needs to be done to inhibit access to the site. The site is not safe. Township Administrator/Clerk Ambrosio discussed placing a temporary fencing until the DEP meeting. Mayor Collamer discussed there should be "No Access" signage as well.

- Faust Park

Township Administrator/Clerk Ambrosio discussed Faust Park is the little park on Oregon Avenue between Illinois Avenue and Oregon Avenue. There has been a metal slide there for many years. The Township was notified it needed to be removed along with the swing set. To replace the swing set is \$5,000. A nice piece of equipment is \$8,000 - \$10,000, if purchased on sale or through a co-op. It is time to update that park. Mayor Collamer discussed the Township should get quotes for a multifunction piece

of playground equipment. Township Administrator/Clerk Ambrosio discussed Township will continue to look for grant money.

Township Administrator/Clerk Ambrosio discussed on today's agenda are the second reading, public hearing on ordinances. Also listed are the support of the Burnetti Tract in the Pinelands and the Department of Transportation (DOT) grant recommendation to do Michigan Avenue as the next street. Township Administrator/Clerk Ambrosio discussed another item on the agenda is Walters Homes needs a resolution to go to the Department of Environmental Protection for their water treatment works approval, which they applied.
