**RESOLUTION NO. 2020 –150**

**RESOLUTION OF THE TOWNSHIP OF OCEAN,  
COUNTY OF OCEAN, STATE OF NEW JERSEY,  
AUTHORIZING A GRACE PERIOD FOR THE  
PAYMENT OF SECOND QUARTER PROPERTY  
TAXES TO JUNE 1, 2020 IN ACCORDANCE WITH  
EXECUTIVE ORDER NO. 130**

**WHEREAS**, the Township Committee of the Township of Ocean, County of Ocean, State of New Jersey (the “Township”) recognizes that the COVID-19 pandemic is unprecedented and is causing severe financial hardship on the residents of the State of New Jersey and the residents of the Township of Ocean; and

**WHEREAS**, second quarter property taxes for the Township of Ocean were due on May 1, 2020; and

**WHEREAS**, the Governor executed Executive Order No. 130 on April 28, 2020, which authorizes municipalities, upon the adoption of Resolution, to extend a 30-day grace period for the payment of second quarter property taxes allowing a grace period for property taxes to be paid no later than June 1, 2020 without penalty; and

**WHEREAS**, the Township Committee of the Township of Ocean finds it necessary and appropriate to adopt this Resolution providing relief to the residents of the Township of Ocean providing them a 30-day grace period to pay their second quarter property taxes.

**NOW, THEREFORE, BE IT RESOLVED** on this 7th day of May 2020 by the Mayor and the Township Committee of the Township of Ocean, County of Ocean, State of New Jersey as follows:
