#### **Committee Reports**

Mayor - Lydia M. Dodd

Thank you for joining us this evening for our regular business meeting.

Tonight, the Township Committee is announcing an "Adopt a Bench" Program. The Township has been contacted by a few residents inquiring to have a bench placed at a park for a family member. The Township will post the information on the Township webpage and have available for pick up in Town Hall. A person or family wanting to donate a bench will be able to choose the park they want the bench placed. It will also include a cast bronze plaque up to 4 lines/28 characters that will be placed on the bench. The donation for a bench is \$1,000.00. The person will be notified upon receipt of the bench and

plaque and will be notified on the date of installation. The Township of Ocean will be responsible for the care and maintenance of the park bench.

Veteran's Memorial Park. The Township will not be holding the Independence Day Celebration this year. The Township is planning a Veteran's Memorial Park. The location is where the old Construction Office trailer was located. The Township will have an event at the time of grand opening of the park in late October.

Vacant Property Registration Report. For the month of April, the Township received \$6,500.00. Total amount receive in 2021 is \$49,250.00.

Zoning Department. 73 applications were approved, 17 applications pending review and 6 denial zoning applications.

Code Enforcement. 67 Notices of Violation, 9 Second Notices of Violation and 12 properties abated their violations.

Construction Department – April. 55 permits issued, 9 permits updated, 34 Certificates of Approval, 4 Certificates of Occupancy, 2 Notices of Violation order to pay penalty (work without a permit), 2 Notices of Violation violating the provisions of the UCC and 1 Notice of Unsafe Structure.

Ordinance 2021-11, Resolutions 2021-148, 2021-149, 2021-150. These items are required by the State of New Jersey for the introduction and reading of the 2021 Municipal Budget. The Budget introduced tonight will be posted on the Township website and the Budget Summary will be published in the Asbury Park Press. The budget being introduced represents a remarkable job of balancing the needs of sustaining a professional municipal operation versus the financial realities of our taxpayers. It is a delicate balance between the two. I firmly believe we have struck that balance with the budget being introduced.

There were some shortfalls in last year's budget due to COVID19. The Township has been able to recover some of the shortfalls with the Ocean County Cares Act funding. The Township continues to review areas that can be improved. The Township is continuing the Shared Service Agreements for cost savings. This year includes a Shared Service Agreement with Little Egg Harbor for a Chief Financial Officer. The Township also shares services and has a part-time Construction Official, Sub-Code Officials, Tax Collector and Tax Assessor for additional cost savings.

There are the annual costs of doing business that go up including pension payments, salaries, fuel, electric, etc. The Township does need to provide the proper items necessary for the departments to continue to do their jobs effectively.

The Township Committee along with the Township Finance Officer and Business Administrator have been working diligently to have the 2021 budget complete. This year even with the Township working hard to keep costs down the Township will have an increase of less than 2 cents (\$0.013). The public hearing to adopt is on June 15, 2021.

Resolutions 2021-153. The sale on GovDeals last month netted the Township \$7,298.02. This resolution is authorizing the sale of items that are no longer in use at the Waretown Volunteer Fire Company. All items can be found on Govdeals.com

Tradewinds. The developer has received approval from the New Jersey Department of Transportation (NJDOT) to complete the curb work on Route 9. As you can see the company is working on these items right now. The developer is working diligently to obtain a Temporary Certificate of Occupancy for Buildings 1 and 2.

#### Deputy Mayor - Ben LoParo

Good Evening, nice to see everyone in the audience this evening.

Ordinance 2021-10. This evening is the 2<sup>nd</sup> Reading, Public Hearing. The wireless Telecommunication industry is utilizing space in public right-of-ways for the installation of small cell wireless facilities. The Township encourages wireless infrastructure investment and wishes to provide a fair process, while preserving the Township's ability to manage public right-of-ways in the overall interest of the public health, safety, and welfare. This ordinance establishes these guidelines.

Ordinance 2021-12. The ordinance being introduced tonight is regarding Cannabis Establishments in the Township. The Township is waiting for the Cannabis Commission to send the actual requirements involving recreational marijuana. The Township of Ocean is not against having recreational cannabis businesses but want to establish them according to the laws, licensing and zoning requirements set by the State. At this time, a business for manufacturing or warehousing must be located in an Industrial Zone. Currently the Township does not have an industrial zone. The Township Committee will be reviewing the zoning necessary to approve the different types of licenses. In the future, the Township will be looking at all the different alternatives, once the Cannabis Commission starts moving. The State has lost tax revenue for five months not having cannabis for sale. It was one of the things that was going to help us, help our schools and help our taxes.

The State of New Jersey when passing the law only gave municipalities a timeline to pass an ordinance. The ordinance must be completed by August 21, 2021. The Township has the ability at any time to opt in with a new ordinance. The Township Committee will be reviewing the zoning and the licenses to determine the best fit and location within the town. The Township Committee is not opposed to recreational cannabis businesses, but would like the opportunity to zone it in the proper locations and put limits, if the Township so desires. The second reading public hearing will be June 15, 2021 at 6pm.

Waretown Bayfront Park & Pier. The Township will be holding a small Grand Opening for Waretown Bayfront Park & Pier (formerly known as Bryant Road Park). The event will be Tuesday, May 25<sup>th</sup> at 11:30 am at the park. A ribbon cutting will take place. All are invited to attend, and the Kona Ice truck will be there providing free flavored ice. Due to COVID19 some of the items will not be in place immediately, as the Township awaits the arrival of the new garbage cans, picnic tables and bathroom. As soon as they arrive, they will be brought to the park. The Township Committee wants the park open for all to enjoy.

Resolution 2021-158. The Township is entering into an agreement with F.R.O.G. Canoe and Kyak Rental LLC for Waretown Bayfront Park & Pier. The Forked River Outdoor Group is a veteran-owned company. The Township went out for a request for proposal for a food truck and a non-motorized sports

concession. At this time, the Township has not received any requests for a food concession. The Township looks forward to a great first season with this company.

Resolution 2021-158. The Township of Ocean Committee support the Police Department in the 2021 Click or Ticket Seat Belt mobilization. Approximately 40% of motor vehicle occupants killed in traffic crashes were not wearing a seat belt. This mobilization will take place from May 24–June 6, 2021.

Resolution 2021-163. This resolution is approving and accepting the grant for "Cops in Shops" Summer shore initiative. The Department of Law and Public Safety, Division of Alcoholic Beverage Control has allocated \$3,520.00 to the Township of Ocean for the assignment.

The Municipal Alliance will be hosting a Drive-In Movie on Saturday, May 22<sup>nd</sup> at 8:00 pm. The movie will be the original "Toy Story". There will be a food truck and ice cream truck at the event starting at 7:00 pm.

#### Committeeman - Ken Baulderstone

Good Evening.

Tonight, I would like to let the residents know, since the State of New Jersey is changing the requirements for events, the Township Committee is announcing the renting of Community Center and renting of Corliss Park Pavilion will start again on Friday, May 21, 2021.

All Township meetings of the Senior Advisory, Special Events Committee and Environmental Commission will reconvene starting June 1, 2021.

Resolution 2021-155. This resolution authorizes project closeout and Change Order #1 for the 2020 Street End Bulkhead reconstruction project. The change order is for additional work that was necessary regarding adjustments for as-built quantities as well as extra work on Cutlass Way and Tiller Avenue. The bulkhead replacement work is complete. The contractor is working on the last few punch list items at various sites.

Resolution 2021-159. This resolution is rejecting the rate increase request by New Jersey Natural Gas. Ocean County residents are still suffering the economic impacts of the ongoing COVID19 pandemic. Seniors and other vulnerable residents may be forced to choose between paying the increase or buying the necessary food and medicine. The Township of Ocean requests the Board of Public Utilities reject this unnecessary rate increase.

Resolution 2021-162. This resolution is supporting a grant application that was sent out by the New Jersey Department of Community Affairs. This Recreation Improvement Grant will be used to complete a walking trail from Royal Oaks Drive to Railroad Avenue. This will formalize an existing informal trail. This provides a strategic connection between existing residential neighborhoods, the Ocean County Rail Trail, recreational facilities, and the school.

The Department of Public Works continues with washing down dead-end manholes, jetting sewer mains in Pebble Beach, installing water and sewer connections at Waretown Bayfront Park & Pier, continuing stormwater maintenance in Sands Point and grading of dirt roads.

2020 Road Project. The road work is being completed including roadway milling, base paving work and restoration work will continue. All should be fully completed by end of May.

Recreation. Due to COVID restrictions, the Township will not be holding the annual summer camp. The Township has hired outside companies that provide camps for children. There is a cost for the outside vendors. Each camp has a separate price for each week. There is a Camp Crafty, New Logic Marine Science Camp, Academy of Amazement Magic Camp and Amazing Athletes of the Jersey Shore Camp. These camps will take place under the pavilion at Corliss Park. There is a Soccer Shots Camp which will take place at Tourney Park. Ocean County Parks Nature series will be holding their programs at Corliss Park & Lake Area each week starting July 21st. The list of camps and classes are posted on the Township website. The forms can be picked up at Town Hall.

Town Wide Yard Sale. As of today, there are 44 homes registered and 21 registered at Corliss Park & Lake Area. The event is FREE. Residents may opt to register their address to be placed on a map that will be distributed. A common yard sale area will be set up at the Corliss Park & Lake Area, for anyone wishing to bring their items to sell. All can participate. The last day to register for the map is Wednesday, June 2, 2021.

REMINDER: Founder's Day events will not take place this year. The fireworks will take place over the bay at dusk at approximately 9:00 pm, weather permitting.

#### Chief of Police – Michal Rogalski

The municipal detention facility, which is the holding processing room, has been inspected on April 12<sup>th</sup> by a staff member from Ronin Security Solutions Group, which is a vendor for the New Jersey Department of Corrections. They are granted the authority to conduct inspections to make sure the department meets the minimum standards for New Jersey municipal detention facilities. As a result of this inspection, the department was informed that the Ocean Township Police Department was to be in full compliance with the requirements set forth. The letter states "You and your staff are congratulated in this achievement and are to be commended for the efforts made in preparation for this inspection. The hard work and dedication by the staff of your facility was evident to the members of the inspection team and certainly deserve a special recognition." This is the second year in a row that we have met and exceeded all requirements.

The Ocean Township Police Department also conducted two food drives through the Police Department in conjunction with the PBA this month, in support of St. Stephens food bank and the Waretown Methodist Church. There were two events, one in Greenbriar and one in the back parking lot by the Fire Department. The food banks are in dire need of food two times a year, right before Summer and around the holidays. The department was able to bridge that gap in our community. It was a job well done by the members of the Police Department.
