# **Committee Reports**

Mayor - Lydia M. Dodd

Thank you for joining us this evening for our regular business meeting. I would like to start with acknowledging that June 14<sup>th</sup> is the 246<sup>th</sup> Birthday of the United States Army. The Township of Ocean commends the soldiers of the United States Army past and present and recognizes the historic significance. The Township expresses the appreciation of the citizens to the United States and the dedicated soldiers. Thank you and Happy Birthday.

Vacant Property Registration Report. For the month of May, the Township received \$1,500.00. Total amount received in 2021 is \$50,750.00.

Zoning Department. 64 applications were approved, 31 applications are pending review and 6 denial applications.

Code Enforcement. 72 Notices of Violation, 8 Second Notices of Violation, 13 properties abated their violations and 2 property liens.

Ordinance 2021-11, Resolutions 2021-150. As discussed at the last meeting, the items listed on the agenda are for the 2021 Budget. Tonight is the public hearing on the Municipal Budget for 2021. The budget presented represents a remarkable job of balancing the needs of sustaining a professional municipal operation versus the financial realities of our taxpayers. It is a delicate balance between the two, but I firmly believe we have struck that balance with the budget being introduced.

There were some shortfalls in the budget last year due to COVID19. The Township has been able to recover some of the shortfalls with the Ocean County Cares funding. The Township continues to review areas that can be improved and is continuing the Shared Service Agreements for cost savings. This year includes a Shared Service Agreement with Little Egg Harbor for a Chief Financial Officer. The Township also shares services for a part-time Construction Official, Sub-Code Officials, Tax Collector, and Tax Assessor for additional cost savings.

There are annual costs of doing business that increase including pension payments, salaries, fuel, electric etc. The Township does need to provide the proper items necessary for the departments to continue to do their jobs effectively.

The Township Committee along with the Township Finance Officer and Business Administrator have been working diligently to have the 2021 budget complete. This year even with the Township working hard to keep costs down the Township will have an increase of less than 2 cents (\$0.013).

Resolution 2021-168. This resolution is required annually for the renewal of approved liquor licenses in the Township.

Resolution 2021-179 and 2021-180. These resolutions are accepting the resignation of the Administrative Assistant in the Construction/Zoning Office and appointing a new Administrative Assistant for that office. The Township would like to welcome Ashley Harper to the team.

Resolution 2021-181. This resolution is authorizing T&M Associates to move forward with the work necessary for the Veteran's Memorial Park. This park will be located in front of the Skate Park on Route 532, where the Construction Office was located. The Township Department of Public Works will be doing some of the work on the park to try and assist in keeping costs down. The Township would like the park to open on or near Veteran's Day.

Tradewinds. As you can see, the builder is continuing the necessary work on Route 9 and site work to obtain a Temporary Certificate of Occupancy (TCO) for Building 1. There are outstanding items that need to be completed prior to obtaining a TCO. If the developer completes the items necessary, there is a possibility of starting to move residents in by the end of the month.

Free COVID Vaccination Clinic. The Ocean County Health Department will be holding a Free COVID-19 Vaccination Clinic on Monday, June 28<sup>th</sup>, from 10am-1pm, at the Ocean County Fire & EMS Academy, 100 Volunteer Way in Waretown. Pfizer 2 dose vaccines or Johnson & Johnson 1 dose vaccines will be available free of charge to all New Jersey residents. COVID 19 vaccinations and immunizations are extremely important for the health and well being of all adults during the pandemic. You can walk-in and register on site.

# Deputy Mayor - Ben LoParo

Good Evening.

Ordinance 2021-12, Second Reading, Public Hearing. Tonight, this ordinance is having the Public Hearing regarding cannabis establishments in the Township. The Township is waiting for the Cannabis Commission to send down the actual requirements involving recreational marijuana. The Township of Ocean is not against having recreational cannabis businesses but wants to establish them according to the laws, licensing and zoning required. At this time, a business for manufacturing or warehousing must be

located in an Industrial Zone. Currently the Township does not have an Industrial Zone. The Township Committee will be reviewing the zoning necessary to approve the different types of licenses.

The State of NJ when passing the law only gave municipalities a timeline to complete an ordinance. The ordinance must be completed by August 21, 2021. The Township has the ability at any time to opt in with a new ordinance. The Township Committee will be reviewing the Zoning and the licenses to determine the best fit and location within the Township.

The Township Committee is not opposed to recreational cannabis businesses but would like the opportunity to zone it in the proper locations. The Township Committee has approved a medical marijuana business within the Township. The company has submitted their zoning permit to start the process to build the store front in the Town Center. The Cannabis Commission still has not set up any guidelines yet.

Resolution 2021-166. This resolution is the separation agreement for Sgt. Mike Ward. Sgt. Ward has worked in the municipality for 23 years and served in the United States Marine Corp. The Township of Ocean would like to thank Sgt. Ward for his dedication to this Township. We wish him all the best in his well-earned retirement.

Resolution 2021-171. This resolution is authorizing the Township to accept the Grant Funding for Body Worn Cameras for the Township of Ocean. The amount to be placed in the budget is \$48,912.00. This covers most of the cost but there is approximately an additional \$20,000 that has not been awarded and the Township will need to pay. This is one step in coming into compliance with the mandate from the State Attorney General.

# Good Evening.

Resolution 2021-167. This resolution authorizes the Township to go out to bid for Garbage and Recycling. The contract in place currently expires this year. The Township is having a combined bid with Barnegat. This assisted the Township a few years ago to obtain a better price to service both towns. The bids are broken down for each town, with a robo can and without. Also, it includes the homes in Greenbriar to obtain a price for household waste. The bids are due on August 25, 2021 at 10:00 am.

Resolution 2021-170. This resolution authorizes Remington & Vernick engineers to provide consulting services for the Water Utility Cybersecurity Assessment Plan for the Township of Ocean Utilities Department. The New Jersey Water Quality Accountability Act requires water purveyors with internet controls and 500 or more service connections to development a Cybersecurity System.

Resolution 2021-172 This resolution is supporting a grant application for the New Jersey Department of Transportation (NJDOT) grant for improvement to Bayview Drive and Marine Road. The Township has

been successful in securing funds for NJDOT projects. The Township would need to review storm drain upgrades when necessary, in the area. This will be discussed upon receipt of the letter from NJDOT.

Clean Communities. The Township has received a check for the Clean Communities funding in the amount of \$22,653.07. This funding is used to offset the cost of Clean Up Weekend.

Clean Up Weekend. The Department of Public Works, in conjunction with the Township's Environmental Commission, held the 19<sup>th</sup> Annual Clean Up Weekend. The weekend was a great success. I would like to thank the Department of Public Works employees for assisting the residents. It ran smoothly and there was a steady stream of residents with trash throughout both days.

Birdsall Water Tank Project. The project continues to move forward. At this time, the tank has been filled for the summer. No major tank painting construction is anticipated this summer. The contract will remobilize in September 2021 to complete the project.

Recreation. The drive-in movie was a great success approximately 230 people were in attendance. The weather was great and it was fun evening for all.

Founder's Day Fireworks over the bay finally took place on Monday, May 29<sup>th</sup>. The Township Committee has received positive feedback on the fireworks and the Waretown Bayfront Park & Pier. All were enjoyed by the citizens who brought chairs to sit at the park and watch the Fireworks display.

The Town Wide Yard Sale took place on June  $5^{th}$  and was very successful. There were 22 registered at the lake and 84 homes were on the map.

Mr. Denning inquired if the Township looked up the tonnage of recyclables compared to garbage before and after Meadowbrook took over to see if the Township is getting ripped off.

Township Administrator/Clerk Ambrosio discussed she does monitor the reports from year to year. The reports are basically the same.

Mr. Denning discussed I'm sure Meadowbrook was cheaper. When the Township used Waste Management, there was never a problem.

Township Administrator/Clerk Ambrosio discussed Waste Management did not bid.

Robert Lange, 2 Shore Drive, thanked Mr. Dasti for getting back to him on his zoning issue. Mr. Lange discussed he is getting more violations than permits. There are so many people that are complaining. Contractors will not work in town anymore. Mr. Lange discussed he is not allowed to drop a building permit off until he has Zoning approval. Then Zoning tells you 10 days. After the 13-15<sup>th</sup> day, maybe you get an answer. Then in 21 days they tell you they have to look at the building permit. Then after 15 days, they say something is wrong. It takes 2-3 months to get a simple building permit.
