Proclamation

Gabriel Shehady - Eagle Scout

Mayor LoParo read and presented the Proclamation recognizing Gabriel Shehady for his outstanding work performed at Corliss Park Lake & Recreation Area during his Eagle Scout Service Project, which involved designing and building twelve (12) outdoor signs containing photos and descriptions of trees, bushes, plants, flowers, insects, reptiles, birds, fish, snakes and safety warnings. The Township of Ocean Committee, Township Administrator, Superintendent of Public Works and the residents are delighted with the results and encourage all citizens to congratulate Gabriel on his efforts and achievements.

Waretown Volunteer First Aid - 60 years of Volunteer Services

Deputy Mayor Ken Baulderstone read and presented the Proclamation recognizing the value and accomplishments of the Waretown First Aid Squad. The Waretown First Aid Squad was first established on April 5, 1962. On behalf of the residents, the Township of Ocean gives their heartfelt gratitude to the dedicated volunteers of the Waretown First Aid Squad. Deputy Mayor Baulderstone encouraged all Township of Ocean residents to celebrate and support the Waretown First Aid Squad organization and their service to our community over the last sixty years.

Committee Reports

Mayor - Ben LoParo

Thank you for coming to the Township Committee meeting this evening.

The Township Committee is working on putting new pieces of playground equipment at Corliss Park Lake and Recreation Area for children. This park is due for a playground upgrade. This park has continued to expand the uses besides the Rotary Pavilion and the addition of the dog park.

The Township Administrator under the direction of the Township Committee has been pursuing and submitting for grants. The Township submitted for a grant and received a \$10,000 grant at this time.

The Township is also sending letters to organizations and businesses to seek donations for the park upgrades. The Township Committee would like to have this completed by Fall.

Tax Bills. The Township tax bills are to be mailed this week. The 3rd quarter taxes will be due on or before September 9, 2022, with no additional grace period. If payment is not received by September 9, 2022, interest will revert back to the statutory due date of August 1, 2022. If a property owner would like to pay prior to receiving the tax bill, they can look up online at the Township website or come into Town Hall to the Tax Office to obtain the payment information.

Municipal Alliance. The drive-in movie was on July 30th. Thirty-two (32) carloads of families attended and enjoyed the Shrek movie. There was a food truck and ice cream truck on site throughout the event.

Deputy Mayor - Ken Baulderstone

Good evening.

Resolution 2022-219. This resolution is for a grant for the Waretown Volunteer Fire Company in the amount of \$41,000.00. The New Jersey Department of Community Affairs (DCA), Division of Local Government Services (DLGS) and Division of Fire Safety (DFS) announced today they are accepting grant applications for the American Rescue Plan Firefighter Grant Program, which is to help local and regional fire departments in New Jersey provide first responders with proper, protective cleaning and sanitization equipment.

After discussing with the Fire Department, the request was completed for a turnout gear washer and dryer and full sets of turnout fire gear. The Township Administrator completed and submitted all grant paperwork. All of these items will also assist in keeping them in PEOSHA compliance.

Resolution 2022-224. This resolution is authorizing T&M Associates to complete the necessary work for a grant. The Township received a Local Recreation Improvement Grant in the amount of \$75,000 for a recreation trail. The recreation trail improvements will be from Royal Oaks Drive to Railroad Avenue. The existing dirt pathway will be replaced with a stone dust trail, similar to the Ocean County Rail Trail and will be 6 feet wide. The project will involve grading and removal of adjacent vegetation and trees as need and the installation of the new surface in amount not to exceed \$28,950.00.

Resolution 2022-228. This resolution awards the bid for the 2021 NJDOT Municipal Aid Program – Improvements to Bonita Road and Lagoon View Drive. The Township received a grant award in the amount of \$401,000.00. The Township has included drainage work on the roads. The drainage work is not covered by the grant. The total cost of the project is \$787,613.13, which is being awarded to the lowest bidder, as per New Jersey State law, to Earle Asphalt company. This work should be started in the Fall this year.

Resolution 2022-229 & 2022-230. The Township is always reviewing the water and sewer system and reviewing the necessary upgrades and maintenance to the system in the most cost-effective ways possible. These resolutions are authorizing Remington & Vernick Engineering to work on a hydraulic study for the Pebble Beach area in an amount not to exceed \$35,000 and also to work on the documents required for the replacement of the Pebble Beach water treatment plant through the New Jersey I-Bank Loan Assistance Program. This will allow for the design, permitting and construction phases in an amount not to exceed \$258,420.00.

Department of Public Works

Power washed tennis and basketball courts at Corliss Park.

Sewer breach on Rahway Road. All lines were jetted.

Worked with the Ocean County Municipal Utilities Authority on reviewing and using a camera to review the pipes in the Barnegat Beach Section of town and can report there was no sited backups or blockages in these PVC pipes.

Recreation Department

Bus Trip to Citizens Bank Park. Rescheduled date is August 20th. Mets vs Phillies game. Tickets are still available - \$75.00 per person. Contact Recreation. Bus Departs 11:15am for the1:05pm game. Seats are in Section 245.

Senior Center/Community Center Calendars are in the back of the room. There are many exercise classes and social recreation including art, bingo, cards, mahjong, bunco and other games. Everyone is welcome to attend. These activities are being well attended. It is a great way to socialize, meet new people and just be out of the house.

Hot meals are served every Monday, Tuesday and Wednesday. Fulfill of Monmouth County provides a boxed lunch for attendees to eat in or take home.

Committeewoman - Lydia M. Dodd

Thank you for joining us this evening.

Resolution 2022-221. The Township is required to keep records in a climate-controlled building until their destruction. Some documents are permanent records. The Township does not have a building that fits the State's requirements and has used an offsite facility called FileBank. This year their fees went up 8% for the basic services.

The Township Clerk/Administrator Ambrosio started researching other avenues for the most important records. The Township has been working on having records scanned. The Township has started in the Construction and Zoning and Utility Departments. This allows for easier research when documents are scanned but this also can be a costly process. The Township continues to have records scanned each year. The information is approved by the New Jersey Department of Archive and Records Management (NJDARM) as required by State law.

Tonight, this resolution is allowing for a shared service for records with Toms River. Toms River has built a facility and has room for the Township records at a lower cost all around. If a department needs a record immediately, they will scan and send it to the Township. The final cost savings will be discussed once all the records have been moved. The Clerk's office believes there are additional records that can be shredded once obtaining the State of NJ DARM's approval.

Ordinance 2022-17. Tonight, the Township is introducing an ordinance for the franchise renewal rights for New Jersey Natural Gas Company. The Public Hearing will be at the September 20th meeting.

Resolution 2022-231. Tonight, I am happy to report, along with the Township Committee, that the 2021 audit is complete. There are no comments or recommendations that need to be corrected. This is the 8th

year that the Audit for the Township of Ocean does not require a corrective action plan. This is a great accomplishment and I thank our CFO and Business Administrator.

Resolution 2022-227. This resolution tonight is reappointing Lori Konecsny as Plumbing Sub-Code Official. Subcode officials are appointed for a 4-year term. This is Lori's 2nd appointment which will grant her tenure in her position as required by New Jersey State Law. Congratulations Lori.

Resolutions 2022-223, 225, 226. These resolutions are returning escrow. These must be completed by resolution.

July 2022 Reports

Zoning Department. 31 applications approved, 7 applications pending review, 3 denial applications.

Code Enforcement. 28 Notices of Violation, 4 Second Notices of Violation, 7 properties abated their violations, 9 Municipal Court Cases, 1 Lien placed on property for failure to maintain property.

Construction. 41 Permits issued, 8 Permit updates, 28 Certificates of Approval issued, 2 Certificates of Occupancy, 3 Notices of Violation - work without permits and 1 unsafe structure.

Chief of Police - Michal Rogalski

Chief Rogalski read the July 2022 Police Report. The Police Department handled 3,791 incidents for police service, 7 abandoned 911 calls, 44 alarms were activated and responded to, 25 animal complaints, 3 residential burglaries, 2,150 business and/or residential checks, 3 acts of criminal mischief were investigated, 1 disorderly person, 6 domestic violence incidents, 11 verbal dispute/harassment complaints, 18 disabled vehicles, 3 DWI arrests, 2 drug arrests, 89 first aid calls, 66 general complaints, 26 motor vehicle accidents, 395 motor vehicle stops-93 motor vehicle summonses issued, 2 juvenile complaints, 7 psychiatric evaluations, 14 various warrant arrests, 1 shoplifting incident, 58 suspicious persons and/or motor vehicles were investigated, 1 theft from a residence and 1 theft from a motor vehicle. Bill Harrington, 42 Jones Road, inquired about the dumping and storing of debris on a property in Brookville, which he mentioned at the last meeting. Mr. Harrington commended the Township Officials and discussed this town has come a long way. The town is really shaping up but the Thirsty Mallard building is in disrepair and inquired if the Township can cut the grass.

Township Clerk/Administrator Ambrosio discussed the grass has been cut on the Thirsty Mallard property. The building, per the Township Construction Official, is not a safety hazard yet. The Township Committee has been pursuing different businesses for that property.

Jim Oris, Township Engineer, discussed the dumping on Jones Road. The Code Enforcement Officer investigated the property, took pictures and issued Violation Notices to the property owner. The matter was reported to Ocean County Solid Waste, who said they had no record of any complaints, and referred us to the New Jersey Department of Environmental Protection (NJDEP). The complaint was also reported to DEP enforcement in Toms River and they are still completing their investigation.
