Committee Reports

Committeeman - Ken Baulderstone

Good evening.

This morning the water tower and the Route 532 water treatment plant experienced low pressure. The Department of Public Works worked diligently to correct the issue. Due to all the sprinklers in Greenbriar going on around the same time in the morning, the pressure can become an issue. The Department of Public Works was able to have all items and pressure back online as quickly as possible.

The water pressure was never under the legal limit as per New Jersey Department of Environmental Protection standards. That is why boiling water or any other precaution did not need to be taken and residents were not informed by the Township of Ocean to boil water or take precautions, as it was not required. The tank and Route 532 water treatment plant will continue to be monitored to ensure this does not happen again. Please note the entire Township used more water last month than ever in the history of the Township.

Resolution 2024-205 & 212. These resolutions are authorizing the close out of the 2021 & 2022 NJ DOT Municipal Aid program for final payment and maintenance bond.

Resolution 2024-206 & 207. Resolutions authorizing the hiring of Jesse Schimmenti as a Full-Time Department of Public Works employee, since an employee resigned. Also, hiring Kevin Hayes as a part-time employee, not to exceed 25 hours per week, for the Department of Public Works for the year 2024. Welcome to the Department of Public Works Team.

Resolution 2024-217. This resolution is rejecting the bid on the Dock Avenue Pump Station upgrades. Only one bid was received and it was over the Engineers' estimate. The Township cannot certify the funding. The Township Utility Engineer and Department of Public Works Superintendent will review the bids to make some changes and rebid the project.

Resolution 2024-218. This resolution is placing a municipal lien on 48 Bay Parkway in the amount of \$343.94 for property maintenance.

Department of Public Works

Made improvements to the park at Crystal Bay Peninsula, adding split rail fencing and Americans with Disabilities Act (ADA) walking path. Installed additional Adopt-A-Bench benches and picnic tables for all to enjoy.

Senior Advisory

June 2024 Construction/Zoning Report

Zoning Department. 33 applications approved, 6 applications pending review and 1 denial application.

Construction. 79 Construction Permits issued, 31 Permit updates, 30 Certificates of Approval, 4 Certificates of Occupancy, 1 Temporary Certificate of Occupancy, 1 Certificate of Compliance, 2 Unsafe Structures and 0 Violations issued.

Construction & Zoning Office Upgrade. The Mitchell Humphrey program, used by Construction and Zoning, now has a portal that is up and running. This is listed on the front page of the Township's website. A resident can request inspections and upload plans and updates. An applicant will be able to pay online and in the office through MuniciPAY. In the coming months some permit applications will be able to be submitted online as long as the application does not require a raised seal. This could change as the State has not set all criteria and is awaiting information from the Licensing Board. Starting July 1, 2024, the State of New Jersey is requiring inspection requests in writing and the portal is accepted as an in-writing request as per State Law. There will be forms on the counter for residents or contractors to complete for setting up an inspection.

Resolution 2024-195. Tonight, I am happy to report along with the Township Committee, the 2023 Audit is complete. There are no comments or recommendations that need to be corrected. This is the 10th year that the Audit for the Township of Ocean does not require a corrective action plan. This is a great accomplishment and I thank our Finance Officer and Business Administrator for this great accomplishment. The audit will be posted on the Township website after tonight's meeting.

Ordinance 2024-14. This ordinance is to update the sign ordinance in the codebook regarding lighted signs. The Township will be installing a permanent sign on the Fire Department Property. This will list all of the events and emergency information for the Town. The Police Chief has grant funding that will pay for the sign. Tonight is the public hearing on this ordinance.

Ordinances 2024-15, 16, 17, 18. These ordinance changes were recommended by the new Construction Official. Due to the ordinance updates and the raising of properties at this time, it is important to implement a "Grading and Drainage" ordinance. All of these ordinances are available on the Township website, as well as at the Township's Clerk's office at no charge.

Projects

Flex Space Warehouses are moving along and are in the rough inspection phase of the project.

Ocean Isles -1^{st} building of 8 units, the permit has been picked up. The next 2 buildings have been dropped off and are in review.

School Taxes. Due to the School Board increasing the School Taxes at 9.9%, the Township's Tax Rate will not be certified until the end of July. This is what is holding up our tax bills. At that time, the Township Tax Department will be able to print the bills and mail them. This will give an extended payment time period. The Township will not have this information until the Township of Ocean's Tax Rate is certified. Once the Tax Rate is certified, a resolution will be completed with a new due date and grace period for the tax bills. An email and Facebook post with the dates will be sent out at that time.

Chief Rogalski read the June 2024 Police Report. The Police Department handled 3,516 incidents for police service, 3 abandoned 911 calls, 49 alarms activated and responded to, 14 animal complaints, 1,802 individual business/residential checks, 1 act of criminal mischief, 4 acts of domestic violence, 20 verbal disputes/harassment complaints, 11 disabled vehicles, 3 drunk drivers, 103 first aid calls, 77 general complaints, 25 motor vehicle accidents, 466 motor vehicle stops which issued 77 summonses, 1 juvenile complaint, 3 incidents of mental health crisis, 22 persons were arrested on various warrants, 12 shoplifting incidents, 47 suspicious persons and/or vehicles were investigated, 5 thefts from a residence were investigated and 8 frauds.
