Committee Reports

Committeeman - Ken Baulderstone

Good evening.

Resolution 2024-257. This resolution is awarding the contract for the refurbishment of the Dock Avenue Pump Station. This is the rebid of the project due to the original bids coming in hirer than anticipated. The award of the contract to T&T Commonwealth Construction Company is in the amount of \$857,400.00.

Department of Public Works

- Dock Avenue Park has been graded and clam shells were added to parking area.
- Repairs were performed on Community Center sinks and toilets.
- Continued jetting maintenance in Pebble Beach.
- Finished removal of all asphalt from Tourney Park from the old tennis court and are preparing for new park equipment.
- Continued hydrant tagging operation as per the Water Quality Accountability Act.
- Monthly water testing has been completed and all items are in compliance.
- Completed water main break repairs at Tulsa Drive and Bayshore Drive.

Ordinance 2024-20. This ordinance revises the promotion process, if two or more Superior Officers need to be hired at one time. This has been reviewed by the Ocean Township PBA and all agree with the change from having three candidates to four candidates. Tonight is the public hearing on the ordinance.

Ordinance 2024-21. This ordinance revises and amends outside employment of off-duty Police Officers. This has been reviewed by the Ocean Township PBA and all agree with the changes. All off-duty outside employment is paid through a contract with the agency/company who hires the Township Police Department on a job site. This is the public hearing.

Resolution 2024-260. This resolution is appointing a full-time dispatcher. The Chief of Police has written a recommendation, since Amanda DeFeo has completed all her training.

Resolution 2024-263. This resolution is authorizing the signing of a Retirement and Separation Agreement for Sergeant James Kinlan. The Township Committee and I commend Sergeant Kinlan on his many years of service to the Township of Ocean and wish him the best in his retirement.

Tonight at 5:00 pm the donated pickleball court lights went on. All items were 100% donated. The Township Committee and I would like to thank Bruce & Debbie Floystad, MRS Airfield Lights and Supplies, and GKS Electric. Without their generous donation of equipment and their time, there would be no lights on the pickleball courts. The lights will be available from 7:00 am – 10:00 pm. First, I would like to thank and acknowledge the 77th Birthday of the United States Air Force which was celebrated on September 18, 2024. The Township Committee commends the United States Air Force,

past and present and recognizes the historic significance of this military branch of the nation's armed forces. Thank you and Happy Birthday.

August 2024 Construction/Zoning Report

Zoning Department. 53 reviewed applications, 51 applications approved, 21 applications pending review, and 2 denial applications.

379 Tuscarora Avenue– In court and told to comply with the clean up or will be fined.

Construction. 87 Construction Permits issued, 9 Permit Updates (NSFD's/minor work/alteration/repairs), 68 Certificates of Approval, 1 Certificate of Occupancy (NSFD's/additions & alterations), 3 CCO's (Continued Certificate of Occupancy), 0 Temporary Certificate of Occupancies, 4 Certificates of Compliance, 0 Unsafe Structures and 0 Violations issued.

Ordinance 2024-24 – 1st Reading. The State of New Jersey Department of Community Affairs implemented on July 22, 2022 lead paint inspections. A lead safe certification is good for two years. After two years, the property owner has to obtain a re-inspection if the tenant leaves. If the tenant doesn't leave after three years from the date of certification, the property must be inspected and a new lead-safe certification will be issued and the cycle starts over. The Public Hearing will be in October.

Resolution 2024-256. This resolution of the Township Committee is requesting the State of New Jersey to end the repeal of the school tax holiday. In a time when food prices, housing costs and utilities continue to substantially increase in New Jersey, the school tax holiday would have provided helpful financial benefits for thousands of households.

Resolution 2024-259. This resolution of the Township Committee tonight is hiring a part-time, fill-in Electrical Inspector on a per diem basis.

Projects

529 Route 9 Unit 15 has a permit for a barber shop called "Coastal Barbers".

57 Johnson Street. The house is completely demolished. The owner will level and grade.

Tourney Park. The old tennis court that could not be repaired has been demolished. The Township has purchased new playground equipment for this area and applied and obtained a grant for workout equipment and \$50,000.00 off the playground equipment. The installation should start before the end of October of this year. The Township has also applied for a grant to build a walking trail around all of Tourney Park. The Township will let you know if this grant is awarded.

Bob Lange, 2 Shore Drive, discussed the lead paint ordinance requires certification for houses that are built prior to 1978 and inquired why do they have to be certified every two years.

Township Administrator/Clerk Ambrosio discussed that is a New Jersey State Law. That is not the Township.

Mr. Lange discussed every time a landlord changes a tenant they have to pay another \$100.00. It is ridiculous to have over 300 tenants and it costs \$100.00 each. That is \$30,000.

Township Administrator/Clerk Ambrosio discussed it can be reviewed and compared against what the other Townships are doing. The Township has to file it and register it with the State of New Jersey. There is other paperwork that has to be completed and uploaded to the Department of Community Affairs.

Mr. Lange discussed he spoke to Township Engineer Jason Worth about the wet area on Keelson Drive. The Township put drainage and stone in there, which pushes the water into the ground and it comes up in the crawlspaces of the houses in the area. When that is full, it runs down Keelson Drive to Southwind Drive, down Tiller Drive and across Admiral Way.
